GENERAL BODY

As per the provision of the Multi State Cooperative Societies Act 2002 and bye-laws of NCUI, the General Body of NCUI comprises of one delegate each from member institutions. The Annual General Body Meeting for the year 2023-2024 was held in the Auditorium of National Cooperative Union of India on 25th September, 2024. The General Body deliberated on various issues concerning overall development of the Cooperative Movement in the country.

GOVERNING COUNCIL

During the year under review, five meetings of the Governing Council were convened on 11.05.2024, 06.07.2024, 21.08.2024, 23.12.2024 and 29.03.2025. The Governing Council in its meetings dealt with various subjects related to the development of cooperative movement and to carry out the activities for fulfilling the objectives of NCUI as per its bye-laws. The Governing Council took various decisions for the growth of NCUI and also for development of the cooperative movement by undertaking such activities which are in accordance with the attainment of the objectives of NCUI.

CHAPTER 2

COOPERATIVE EDUCATION & TRAINING

Glimpses of the Education & Training Programmes conducted during the year 2024-2025

1. National Centre for Cooperative Education has conducted 3-days' Leadership Development Program (LDP) for Chairpersons & Women Directors of Cooperatives of India from 8 to 10 April, 2024 at NCCE, New Delhi. Total 52 representatives of Cooperatives from the states Goa, West Bengal, Maharashtra, Manipur, Sikkim, Chhattisgarh, Odisha, Andhra Pradesh, Gujrat etc participated in this program.

3. Three-days Leadership Development Programme for Chairpersons & Directors of Labour Cooperatives of India was held today on 29 April – 1 May, 2024 at NCCE, New Delhi. A total of 48 representatives of Cooperatives from various states participated in this programme.





4. Certificate Course on Financial Accounting and Taxation conducted from May 1st, 2024 - May 31st, 2024. Total of 29 enthusiastic participants from diverse states including West Bengal, Chhattisgarh, UP, Manipur, Delhi, Gujarat, and Maharashtra embarked on a journey of learning and professional development.



5. A three-day Leadership Development Programme focusing on Urban Cooperative Banks (UCBs) and Credit Societies began on May 29, 2024, at the National Institute of Rural Banking (NIRB), Bengaluru. A diverse group of 30 participants from various states, including Gujarat, Madhya Pradesh, Andhra Pradesh, Maharashtra, and Karnataka, are attending the programme.





6. Three-days' Leadership Development Program (LDP) for Chairpersons & Directors of Dairy Cooperatives of India was held on 12 to 14 June, 2024 at NCCE, New Delhi. A total of 49 representatives of Cooperatives from states like Tripura, UP, Gujrat, Assam, Tamilnadu, MP etc. have participated in this program.



7. A three-day refresher course for Project Officers and Farm Guidance Instructors (FGIs) from the NCUI Cooperative Education Field Project conducted from 19 -21 June 2024. The refresher course is designed to update participants on the latest developments in the cooperative sector.





8. The National Centre for Cooperative Education (NCUI), in collaboration with the Office of the Registrar of Cooperative Societies Delhi and the Delhi State Cooperative Training Centre, successfully organized a one-day training programme focusing on the Delhi Cooperative Societies Act 2003 and Rules 2007. The event saw the participation of 45 attendees.





9. The 3-days' Leadership Development Program (LDP) for Chairpersons & Directors of SC/ST Cooperatives of India was held on 24 to 26 June, 2024 at NCCE, New Delhi. A total of 36 representatives of Cooperatives from various states have participated in this programme.





10. The third batch of the two-week Entrepreneurship Development Programme for women cooperators, organized by the National Centre for Cooperative Education (NCCE) in collaboration with the National Small Industries Corporation (NSIC). A total of 37 participants from Assam, Chhattisgarh, Jammu, Manipur, Arunachal Pradesh, West Bengal, Odisha, and Uttar Pradesh have attended this programme.





- 11. A two-week certificate course in Cooperative Law and Practices was organized from 22 July to 2 August 2024, in collaboration with Guru Gobind Singh Indraprastha University (GGSIPU). The program has drawn a diverse group of 20 participants from various states, including Manipur, Arunachal Pradesh, Delhi, Uttar Pradesh, Karnataka, Bihar, and Gujarat.
- 12. Inauguration ceremony of 3-days (24 to 26 July 2024) Leadership Development Program (LDP) for Chairpersons & Directors of Housing Cooperatives of India at NCCE, New Delhi was held on 24 July. A total of 63 representatives of Cooperatives from various states participated in this programme.



13. A five-day refresher course in Cooperative Policy and Development was Organized from 5-9 August 2024 The event was graced by Shri Kapil Meena, IAS, Director, Ministry of Cooperation, and Smt. Savitri Singh, Deputy Chief Executive, NCUI. This program has gathered a total of 37 participants, representing various universities from states such as Assam, Meghalaya, Jammu & Kashmir, Maharashtra, Karnataka, Haryana, Chhattisgarh, Kerala, Gujarat, Bihar, Tamil Nadu, and Uttar Pradesh.





14. NCUI successfully conducted a two-days training programme on "Cooperation and Cooperative Management" for the officials of KRIBHCO at Hazira plant in Gujarat, from 21-22 August 2024. The programme witnessed active participation from 40 middle-level officials of KRIBHCO.



15. On 22nd August 2024, the National Centre for Cooperative Education of NCUI organized a study visit for 13 M. Com Cooperative Management students from Tranqvebar Bishop Manikam Lutheran College, Tamil Nadu





16. NCCE organized a three-day Leadership Development Programme for Directors and Secretaries of the Amreli District Cooperative Union from 3rd to 5th September 2024 at NCUI, New Delhi.



17. The National Centre for Cooperative Education has successfully organised five-days Training of Trainers (ToT) programme 9th to 13th September 2024. This comprehensive training initiative aims to empower 46 participants from Gujarat, Maharashtra, Karnataka, Kerala, Andhra Pradesh, Arunachal Pradesh, Assam, Sikkim and Madhya Pradesh, equipping them with advanced skills and knowledge to excel in their respective roles as trainers within their organizations.



18. The 29th Online Diploma in Cooperative Education and Development commenced on 7th October 2024, with a total of 50 participants representing various states including Arunachal Pradesh, Maharashtra, Madhya Pradesh, Uttar Pradesh, Karnataka, Delhi, Chhattisgarh, and Nagaland. The 12-week diploma, which runs until 22nd December 2024, was organized by NCCE.







19. A team C-PEC Accreditation validation, BIRD, Lucknow visited NCCE for inspection to provide accreditation of NCCE training Programme in NCUI campus on 3rd -4th October, 2024.

24. The participants of the 29th Diploma in Cooperative Education and Development embarked on a study visit to Punjab to gain practical insights into the cooperative structure and functioning in the region. The participants visited the Harsha Cheena Multi-Purpose Cooperative Society in Amritsar, Markfed in Jalandhar, Lambra Kangri Multi-Purpose Cooperative Society, Unnati Cooperative Marketing and Processing Society, Verka Milk Plant, Hoshiarpur and also visited an NCUI Project adopted farmer's Dragon Fruit Farm at Bajwara in Punjab.



25. The contact classes for the 29th Diploma in Cooperative Education and Development commenced on 16 December 2024 at NCCE, New Delhi. Smt. Savitri Singh, Deputy Chief Executive, NCUI, welcomed the participants. The session featured Dr. K.K. Tripathy, IES, Economic Advisor, Ministry of Health, as a special guest. Dr. Tripathy addressed the participants and delivered an insightful presentation on the Indian Cooperative Movement and the Future of Cooperative Education and Training.





26. A five-day training programme on "Formation of Cooperative Societies" commenced on 6th January 2025, aiming to equip students, freshers, and new entrants to the cooperative sector with the necessary knowledge and skills. The programme was held at NCCE, and has drawn participation of 64 individuals representing states like Madhya Pradesh, Chhattisgarh, Sikkim, Odisha, Haryana, Karnataka, Maharashtra, Uttar Pradesh, Jammu & Kashmir, and Delhi NCR.



27. A delegation from the Manjeri Circle Cooperative Union, Malappuram district, Kerala, comprising 58 participants and 4 coordinators, visited the (NCCE), New Delhi, on 14th January 2025. The group included Chairmen, Directors, Secretaries, and CEOs of Primary Agricultural Credit Societies (PACS).





28. The NCCE successfully organized a three-day Leadership Development Programme for cooperators from the Sikkim State Cooperative Union from 21-23 January 2025. The programme saw the active participation of 50 cooperators, aimed at enhancing their knowledge and skills in cooperative management and governance.



29. NCCE successfully organized a three-day training programme on the "Export of Agricultural, Processed, and Value-Added Products" from 21-23 January 2025. The programme witnessed the participation of 40 representatives from nine states, including Jammu & Kashmir, Karnataka, Sikkim, Chhattisgarh, Madhya Pradesh, Gujarat, Rajasthan, Uttar Pradesh, and Delhi.





30. On 5th March 2025, 45 students from the Bachelor of Social Work (BSW) program, Semester VI, of Fule-Ambedkar College of Social Work, Gadchiroli, Maharashtra, visited the NCCE, as part of their study tour.





31. The NCCE organized a two-week Entrepreneurship Development Programme for Women, aimed at enhancing skills and promoting self-reliance among women entrepreneurs. This program, held in collaboration with the National Small Industries Corporation (NSIC), which commenced on 17 March 2025 and has attracted 28 women participants from the states of Arunachal Pradesh, Manipur, West Bengal, Gujarat, Karnataka, Ladakh, Uttar Pradesh, Madhya Pradesh, and Rajasthan.

Cooperative Education Field Projects

1. Introduction

As a special initiative to strengthen the cooperative movement in cooperatively under-developed states and regions, and to reduce regional disparities in development, the Government of India approved the Cooperative Education Scheme in 1976. This scheme is implemented by the National Cooperative Union of India (NCUI) with the aim of promoting cooperative principles and practices at the grassroots level. It is a Central Sector Scheme, fully funded by the Ministry of Agriculture and Farmers Welfare, designed to empower cooperatives and enhance their role in improving the socio-economic conditions of their members.

2. Objective

The primary objective of the scheme is to develop and promote cooperative societies in the identified project areas. These societies serve as a platform to mobilize and empower farmer members by encouraging collective efforts, sharing of resources, and mutual support. Through these cooperatives, the scheme aims to enhance the productivity of farmer members by providing them with access to education, technical guidance, and improved agricultural practices. Ultimately, the objective is to uplift their socio-economic conditions and contribute to the overall development of rural communities

3. Approach

Intensive efforts for cooperative development through Cooperative Education, combined with farm and technical guidance, form the core of the project approach. Office bearers and members of the project-adopted societies are motivated and educated to implement business development plans through their active participation in planning business activities, operational management, and evaluation. Self Help Groups are formed by project personnel to facilitate micro-credit and promote sustainable income-generating activities. The formation and functioning of these groups are rooted in cooperative culture. All educational, farm guidance, and developmental activities are closely linked with the business development plans of PACS/LAMPS adopted by the projects for their overall development.

4. Bench Mark Survey

- A benchmark survey is a comprehensive data collection process used to establish a baseline of information against which future progress and performance can be measured.
- In the context of cooperatives, a benchmark survey helps to assess the current state of operations, member satisfaction, economic impact, and other critical factors.
- This information is crucial for setting goals, developing strategies, and monitoring progress over time.
- · A benchmark survey provides valuable ins ights that are essential for strategic planning and



continuous improvement in cooperatives.

- By systematically collecting and analysing data, cooperatives can set realistic goals, monitor progress, and make informed decisions that drive growth and member satisfaction.
- 5. The National Cooperative Union of India (NCUI) is implementing the Central Sector Scheme aimed at intensifying Cooperative Education across the country. This is being carried out through 34 Cooperative Education Field Projects, which include specialized Women Projects and North Eastern Region Projects. These projects are strategically located in cooperatively underdeveloped states, under-developed regions within developed states, and Union Territories. The purpose of this wide geographic coverage is to address regional imbalances and ensure inclusive cooperative development, as detailed below: -

6. Project Activities: -

The Project activities are divided mainly in to four parts:

- i) Educational / Development activities.
- ii) Farm / Technical guidance activities.
- iii) Socio-Developmental activities.
- iv) Women development activities.
- i. Educational / Development activities: Educational and Development activities are designed to empower members with the knowledge and skills needed to enhance their personal development, improve the cooperative's operations, and contribute positively to their communities. The Educational and Development activities, cooperatives can enhance the capabilities of their members, improve operational efficiency, and contribute to the overall success and sustainability of the cooperative.
- ii. Farm / Technical guidance activities: Farm and Technical guidance activities are crucial for enhancing the productivity, sustainability, and profitability of farming operations. These activities provide members with the knowledge, skills, and tools needed to adopt best practices, implement new technologies, and improve their overall agricultural performance. The Farm and Technical guidance activities, cooperatives can enhance the knowledge, skills, and productivity of their members, leading to improved agricultural practices, increased incomes, and sustainable development.
- iii. Socio-Developmental activities: Socio-developmental activities focus on improving the social, economic, and cultural well-being of their members and the communities they serve. These activities help cooperatives to contribute to the overall development of society while fostering a sense of community, solidarity, and mutual aid. By engaging in these Socio-Developmental activities, cooperatives can play a significant role in fostering inclusive and sustainable community development. These activities not only improve the quality of life for members but also strengthen the cooperative's social impact and relevance in the community.



iv. Women development activities: Women development activities aim to empower women, promote gender equality, and enhance the socio-economic status of female members. These activities can lead to increased participation of women in cooperative leadership, improved economic opportunities, and overall community development. By implementing these women development activities, cooperatives can create a more inclusive and equitable environment that empowers women, promotes gender equality, and enhances the overall success and sustainability of the cooperative.

Skill Development Programme: Skill development programs are essential for enhancing the capabilities of members, improving operational efficiency, and ensuring the long-term sustainability of the cooperative. These programs focus on a range of skills, from basic literacy and numeracy to advanced technical and managerial competencies. By investing in these skill development programs, cooperatives can enhance the capabilities of their members, improve productivity, and contribute to the overall success and sustainability of the cooperative.

7. Progress:

- Progress in a cooperative can be measured across various dimensions, including financial performance, member satisfaction, operational efficiency, social impact, and governance.

CHAPTER 3

GENERAL COOPERATIVE POLICY

The General Cooperative Policy (GCP) Division organized a number of events during the year 2024-25 which includes Workshop on Promotion and Development of Cooperatives in Ladakh, Tripura and Sikkim states. A Symposium also organized in NCUI for National & State level Multi-State Cooperative Societies followed by a national level conference of National Cooperative Federations and State Cooperative Unions to deliberate & chalk-out the strategies to celebrate the IYC2025 in the country. A brief detail of the programmes / event is illustrated in succeeding paras.

Workshop on "Promotion and Development of Cooperatives in Ladakh: 30 & 31 August, 2024"

NCUI has successfully organized a two-day Workshop on Promotion and Development of Cooperatives in Union Territory of Ladakh from 30th to 31st August, 2024. The Chief Guest at the inaugural ceremony was Dr. Pawan Kotwal, IAS, Advisor to Hon'ble Lieutenant Governor, Union Territory of Ladakh. The workshop was chaired by Shri Dilip Sanghani, President, National Cooperative Union of India.

Prominent dignitaries who were present in the conference included Shri Pradeep Kumar (Governing Council Member, NCUI), Dr. Sudhir Mahajan (Chief Executive, NCUI), Shri Sajjad Qadri (Additional Registrar, Cooperative Societies, Ladakh), Deputy Registrar Cooperative Societies, Leh and Kargil. Around 350 dignitaries from all over the country participated in the program. Backdrop and digital posters were designed on the basis of the theme and the same were shared to all other cooperatives organisations to disseminate the same to all the concerned to increase the awareness about coop sector. Many activities like webinar etc. were also held during this one-week period. After the programme press release was prepared about celebration and circulated to the media for wide coverage.

The Cooperator - Monthly Journal

The Cooperator is a monthly journal published by NCUI, featuring both English and Hindi. It serves as a regular communication channel for the cooperative fraternity, including cooperative institutions. All issues of The Cooperator were published on schedule and distributed to all subscribers and also uploaded at the NCUI website. 'Sahakar Jagran'



The magazine has received widespread appreciation from readers, cooperative institutions, and policymakers. Its multilingual approach has been especially significant in expanding outreach to rural and semi-urban cooperative members, many of whom engage better in their regional languages.







NCUI organizes First Youth Cooperative Research Conference







Division successfully organized a First Cooperative Youth Research Conference on March 20-21, 2025, to commemorate the International Year of Cooperatives. The conference, themed "Cooperatives: Key for Achieving SDGs," was sponsored by IFFCO, NCCF, Souharda Federation, Unnati, and Power Gilt. Out of 90 abstracts, 20 were selected for presentation submitted by researchers under the age of 40 years. The conference was inaugurated by Dr. Sudhir Mahajan, Chief Executive of NCUI, in the presence of distinguished dignitaries, including Prof. C. Pitchai (Gandhigram Rural Institute, Tamil Nadu), Dr. Mallika Kumar (Associate Professor, SRCC) and senior officials of the NCUI. In his inaugural address, Dr. Mahajan emphasized the role of cooperatives in achieving Sustainable Development Goals (SDGs), highlighting NCUI's initiatives such as NCUI Haat, Coop Kitchen and the NCUI Incubation Centre. Dr. Mahajan encouraged young researchers to focus on the practical applications of their findings. Dr. Pitchai praised the uniqueness of the event in fostering young cooperative researchers, while Dr. Mallika Kumar stressed the importance of appointing "Youth Ambassadors of Cooperatives in educational institutions to enhance awareness during IYC 2025. The event commenced with a keynote address by Dr. Yashwant Dongre, Vice-Chancellor Chanakya University and Chair of the Asia Pacific Regional Research Committee of the International Cooperative Alliance (ICA) Dr. Dongre highlighted emerging research areas within the cooperative sector and emphasized the role of cooperatives in advancing sustainable development. He urged researchers to produce studies with global relevance in addressing local challenges. A panel discussion on "Cooperatives, Youth, and Sustainable Development Goals (SDGs)" comprising Prof. C. Pitchai, Dr. Mallika Kumar, and Sanjay Verma as panelists was held which explored how cooperatives can drive youth engagement and contribute to the SDGs. Notable case diverse studies included SEWA's Srujan Cooperative, the VYBECOS Ponnurunni Model (an urban waste management cooperative), and AYCOOPS, a cooperative media initiative. Other presentations examined the role of health cooperatives in advancing the SDGs, cooperative's contributions to climate change mitigation, their potential in India's gig and platform economy, and the use of digital platforms and Al to enhance cooperative operations and sustainability. During the valedictory function, chief guest sh. Santosh Shukla, General Manager of IFFCO underscored the importance of youth engagement in IYC 2025 and praised NCUI's Coop Connect initiative for popularizing the cooperative model among young people. Sh. Jyoti Saroop, Director of Unnati, also emphasized the need for youth to consider careers in the cooperative sector.

CHAPTER 6

INTERNATIONAL RELATIONS

The International Relations division carried out the following activities during the year 2024-25:

1. The International Day of Cooperatives is an annual celebration of the cooperative movement around the world. It has been observed on the first Saturday of July ever since 1923 by the International Cooperative Alliance (ICA). The International Cooperative Day 2024 was celebrated on 6th July, which was also the 3rd Foundation Day of the Ministry of Cooperation, Govt of India by organizing 'Sahkar Se Samriddhi ' Conference at Mahatma Mandir, Gandhinagar, Gujarat. The event was organized with collaboration of national level cooperative federations and the cooperative organizations of Gujarat. The theme for the 102nd International Cooperative Day was- "Cooperatives Build a Better Future for All". Hon'ble Union Minister for Home and Cooperation Shri Amit Shah Ji was the Chief Guest on the occasion. Shri Shah emphasized the significance of making cooperatives a robust pillar to bring facilities, prosperity, and selfconfidence to millions of poor people across the country. Other key dignitaries including Union Minister of State for Cooperation Shri Murlidhar Mohol, Gujarat Chief Minister Shri Bhupendra Patel, Minister for Cooperation Gujarat State Shri Jagdish Bhai Panchal, Gujarat Legislative Assembly Speaker Shri Shankarbhai Chaudhary, Deputy Speaker Shri Jethabhai Ahir, NCUI President and IFFCO Chairman Shri Dileephai Sanghani, ICA-AP President Shri Chandrapal Singh Yadav, Shri G. H. Amin, Shri Jyotindra Mehta, Shri Konduru Ravinder Rao, Union Ministry of Cooperation Secretary Shri Ashish Bhutani were present. The highly successful event saw participation of around 5000 cooperative delegates from all parts of the country.









2. NCUI Celebrates International Women's Day 2025: Calls to "Accelerate Action" for Women's Empowerment through Cooperatives - NCUI marked International Women's Day 2025 with a vibrant celebration at its headquarters in New Delhi, reaffirming its commitment to empowering women through the cooperative movement. The event was held as part of the activities commemorating the United Nations-designated International Year of Cooperatives 2025 (IYC2025) and was attended by over 300 women leaders and members from cooperatives across the country. Aligned with this year's United Nations theme "Accelerate Action," the celebration underscored the urgency of advancing gender equality and sustainable development through inclusive cooperative models. The programme commenced with introductory remarks by Mrs. Savitri Singh, Deputy Chief Executive, NCUI, followed by the ceremonial lighting of the lamp and a traditional Ganesh Vandana. Dr. Sudhir Mahajan, IAS (Retd.), Chief Executive, NCUI, welcomed the participants and outlined NCUI's initiatives to strengthen women's roles in cooperatives. Dr. Bijender Singh, Vice President, NCUI, and Dr. Chandra Pal Singh Yadav, President, ICA – Asia Pacific, shared their insights on the growing importance of cooperatives in empowering women and reducing gender disparities at the grassroots. As a key highlight, NCUI felicitated ten distinguished women cooperative leaders from different sectors and states for their exceptional contributions to the cooperative movement. In a move to further entrepreneurship and skill-building, certificates were distributed to trainees who successfully completed the Entrepreneurship Development Programme (EDP) under NCUI's Incubation Centre. A thematic street play by LiftuPro added a cultural and emotional layer to the event, creatively portraying challenges and triumphs in the journey toward women's empowerment. The programme concluded with a formal Vote of Thanks by Shri Ved Prakash Setia, Executive Director, NCUI, who expressed gratitude to all dignitaries, guests, and participants for their active involvement and support. NCUI's celebration of International Women's Day 2025 served not only to recognize the achievements of women in cooperatives but also to galvanize continued efforts to promote gender equality and cooperative-led development across India.













3. The United Nations organized the Soft Launch of the International Year of Cooperatives (IYC) 2025 at its headquarters in Manhattan, New York, on Tuesday, July 9, 2024. The IYC 2025 aims to highlight the role of cooperatives in achieving sustainable development goals and promoting social and economic inclusivity. The soft launch event provided a vital platform to promote the formation of national and international committees dedicated to support the cooperative movement. These committees will play a crucial role in implementing the objectives and initiatives of IYC 2025. A distinguished delegation from India, led by Dr. Chandra Pal Singh Yaday, President of the International Cooperative Alliance Asia-Pacific (ICA-AP), participated in the Soft Launch Event. Joining Dr. Yadav in representing India were several prominent figures from the cooperative sector: Shri Dileep Sanghani, President of the National Cooperative Union of India (NCUI); Dr. Bijender Singh, Vice President of NCUI; Shri Jethabhai Ahir, Chairman of the National Agricultural Cooperative Marketing Federation of India (NAFED); and Dr. Sudhir Mahajan, Chief Executive of NCUI. The presence of the Indian delegation at this significant event emphasized on India's commitment to advance the cooperative movement at both national and international levels. The delegates participated in discussions and activities aimed at encouraging greater collaboration and support for cooperatives globally. This event will help materialize cooperative goals and strengthening the imp









4. The ICA Global Cooperative Conference & General Assembly 2024 was successfully organized from 25-29 November 2024 at Bharat Mandapam, New Delhi. This prestigious international event served as a platform for leaders of ICA-member cooperative organizations to share ideas, engage in policy debates, and enhance the global positioning of cooperatives. The event ensured that the cooperative movement's voice was heard and their interests were represented at the international level. The conference was inaugurated by the Hon'ble Prime Minister of India, Shri Narendra Modi, who highlighted the transformative potential of cooperatives in addressing global challenges. Addressing a distinguished audience of over 3000 cooperators, including Bhutan's Prime Minister Dasho Tshering Tobgay, Fiji's Deputy Prime Minister Manoa Kamikamica, and the International Cooperative Alliance (ICA) leadership, the Prime Minister proposed a visionary global financial platform to support weaker cooperatives and unlock their full potential. A key highlight of the event was the official launch ceremony of the United Nations International Year of Cooperatives (IYC2025), held on 25 November 2024. The ceremony was graced by representatives from the highest offices at the United Nations, allied agencies, and selected member states, underscoring the global importance of cooperatives in achieving sustainable development. The IR division actively coordinated the participation of Governing Council Members of NCUI, its officials, youth cooperators, women cooperators, and representatives from member institutions of NCUI. The division also managed NCUI's exhibit at the Cooperative Haat, where cooperative products and initiatives were showcased, reflecting NCUI's commitment to promoting grassroots cooperatives and their impact on communities. This event marked a significant milestone in celebrating and advancing the transformative role of cooperatives worldwide.







5. Foreign Delegates' Visits to NCUI during the Year 2024–25

5.1. A delegation from the Cooperative Institute of Malaysia (IKMa) headed by Datuk Mohd Ali bin Mansor, Director General accompanied by Mr. Azizul bin Alias, Board of Directors, Dato' Haji Zazali bin Haron, Board of Directors and Dr. Mohd Shahron Anuar bin Said, Head of Research Centre visited the National Cooperative Union of India (NCUI) on 26 November 2024. The interaction provided an excellent platform for exchanging ideas, sharing best practices, and strengthening international cooperative relations.

Dr. Sudhir Mahajan, Chief Executive, welcomed the delegation and provided an overview of the activities and new initiatives of NCUI to strengthen the Indian Cooperative Movement, which was followed by a detailed presentation by Mr. Ritesh Dey, Executive Director on the Indian Cooperative Movement and the pioneering role of NCUI for empowerment of the Cooperative sector in India with focus on Cooperative Education and Training structure. The delegation expressed keen interest in NCUI's efforts and appreciated the work done in promoting cooperative principles and fostering development. Post-meeting, the delegation visited the Cooperative Haat and Coop Kitchen to witness NCUI's efforts for providing marketing platform for the lesser-known Cooperatives and SHGs and women empowerment. They were impressed with the innovative projects and applauded the tangible outcomes in empowering communities through cooperative initiatives. The interaction concluded on a positive note, laying the groundwork for future collaboration between NCUI and IKMa to advance cooperative goals globally.









5.2 A delegation of 30 Brazilian leaders of agro-industrial cooperatives, led by Mr. Marco Antonio Polizel Camilli, visited NCUI on 28th November. The delegation comprised key players in the Brazilian agribusiness sector, who have collectively generated a turnover of approximately USD 40 billion by 2024. Their visit to India coincided with their participation in the ICA Global Conference 2024 and the global Launch of the International Year of Cooperatives 2025 (IYC 2025). The visit to NCUI aimed to explore mutual business opportunities between Brazilian and Indian cooperatives, engage with Indian agribusiness stakeholders to gain insights into their business management practices, share experiences with prominent cooperatives in India and strengthen cooperative ties and explore collaborative ventures in the context of IYC 2025, which emphasizes the role of cooperatives in driving global prosperity and sustainable development. Dr. Sudhir Mahajan, Chief Executive, welcomed the delegation and provided a comprehensive overview of NCUI's activities/programs, new initiatives, its pivotal role in the Indian cooperative movement, and key initiatives aligned with the objectives of IYC 2025. Dr Mahajan emphasized the importance of the International Year of Cooperatives 2025 as a global platform to highlight the transformative power of cooperatives in fostering inclusive growth, enhancing livelihoods, and building sustainable communities. Mr. Ritesh Dey, Executive Director, came up with a detailed presentation on the Indian Cooperative Movement, focusing on NCUI's efforts in promoting cooperative development across various sectors and its contributions to advancing the cooperative agenda globally.

The visit was followed by a strategic meeting on enhancing collaboration between the global cooperative movement and India's robust cooperative network. Mr. Douglas expressed his deep interest in engaging with the leaders of the Indian Cooperative Movement, as well as representatives from the diverse network of ICA members in India. This meeting provided a platform for rich discussions on strengthening cooperative efforts and promoting global partnerships.







5.6 A delegation of 42 cooperative representatives from the National Federation of Honduras Credit Unions (FACACH) visited NCUI. The delegation, led by Mr. Celvin Leodan Valladares, President of the Board of Directors, FACACH, included representatives from various cooperative organizations, such as ELGA, CACIL, CEIBENA, COOPACYL, TAULABE, PESPIRENSE, and SAGRADA FAMILIA. The meeting was attended by Dr. Chandrapal Singh Yadav, President of the International Cooperative Alliance Asia-Pacific (ICA-AP); Dr. Sudhir Mahajan, Chief Executive of NCUI; Mrs. Savitri Singh, Deputy Chief Executive of NCUI; and other senior officials of NCUI. During the meeting, participants engaged in a productive exchange of ideas and best practices, focusing on the cooperative movement in both India and Honduras. A presentation titled "Role and Functions of NCUI: Initiatives for Empowering Cooperatives" was delivered by Mrs. Savitri Singh, highlighting NCUI's role in strengthening cooperatives and empowering communities.











5.7 A high-level 15 member Brazilian Agricultural Delegation, led by Mr. Luis Alberto, President, Sistema OCB/Go, and Mr. Rajnish Magan, visited NCUI. The delegation sought to gain insights into India's agricultural cooperative sector and participated in an interactive meeting held in the NCUI Board Room. The meeting served as a dynamic platform for exchanging ideas, sharing best practices, and exploring potential collaborations in the cooperative sector. Key discussions revolved around cooperative strategies, sustainable agricultural practices, and policy frameworks, enabling mutual learning and strengthening international cooperative ties.









5.8 The International Cooperative Alliance (ICA) officers Ms. Gretchen Hacquard, Director of Membership & Mr. Santosh Kumar, Director of Legislation visited NCUI on 22.04.2024. The interaction meeting with ICA officers served as a valuable platform for exchanging ideas, exploring collaboration opportunities & strengthening ties between NCUI & ICA. Both parties expressed commitment to working together to advance the cooperative movement & promote its role in achieving sustainable development goals (SDGs).





5.9 NCUI hosted a delegation from the Brazilian Agriculture and Livestock Confederation (CNA). The meeting, can be considered as a significant step towards promoting engagement and exploring potential partnerships between the two organizations. The CNA delegation, including Ana Fruci, Bia Fernandes, and Dhruvika Sodhi, Technical Agriculture Officer at the Embassy of Brazil, had a productive discussion with NCUI representatives. The meeting included an insightful exchange of ideas about the activities of both organizations, exploring potentialities for future collaborations. Mrs Savitri Singh, Deputy Chief Executive, NCUI, welcomed the delegates and provided a comprehensive overview of NCUI's pivotal role and functions within India's cooperative ecosystem. NCUI's Executive Directors, Mr. Ashish Dwivedi, Mr. Ved Prakash Setia, and Mr. Ritesh Dey, also participated in the interaction. Ms. Inderpreet Kaur, Assistant Director, NCUI coordinated the meeting. This visit, which is a part of CNA's first mission to India, underscores the growing interest in strengthening cooperative



ties and building meaningful connections between the Indian and Brazilian agribusiness sectors.





- 6. International Training Programme of Centre for International Cooperation and Training in Agricultural Banking (CICTAB), Pune for members of the South Asian Association for Regional Cooperation (SAARC) Countries in collaboration with National Cooperative Union of India (NCUI)
- The National Cooperative Union of India (NCUI), in collaboration with CICTAB, organized 6.1 an International Programme on Cooperative Governance for the CEOs and Senior Executive of Cooperatives & Rural Financing Institutions from February 4-7, 2025, in Hyderabad, to mark the International Year of Cooperatives 2025. The key dignitaries, were Shri Konduru Ravinder Rao (Chairman, NAFSCOB), Shri Ramesh Bung (Member Education Committee, NCUI), Smt. Savitri Singh (Deputy Chief Executive, NCUI), and representatives from CICTAB and Telangana cooperative institutions. With 25 participants from India and Nepal, the program aims to enhance leadership and governance skills among cooperative CEOs and senior executives. It serves as a platform for knowledge-sharing, capacity-building, and global best practices in cooperative governance. As part of the four-day International Programme on Cooperative Governance a comprehensive field visit was organised aimed to provide participants with firsthand exposure to the operational structures and governance models of various cooperative societies. The valedictory session was attended by notable dignitaries, including Dr. Sudhir Mahajan, Chief Executive, NCUI; Mrs. Savitri Singh, Deputy Chief Executive, NCUI; Mr. Ramesh Bhandari, Director, Mahesh Bank; and Mr. H.S.K. Tangirala, Former Director, ICM Hyderabad. Dr. Sudhir Mahajan provided an overview of NCUI's current initiatives and strategic developments aimed at enhancing the cooperative ecosystem in the country. He also highlighted the United Nations-declared International Year of Cooperatives 2025 (IYC 2025) and shared NCUI's plans for the celebration, under the guidance of the Ministry of Cooperation. The programme concluded with a felicitation ceremony, where Dr. Mahajan presented Certificates of Participation, group photographs, and mementos to the participants.















6.2 In commemoration of the International Year of Cooperatives 2025 (IYC2025), NCUI, in collaboration with CICTAB and the Gujarat State Cooperative Union, organized an International Programme on "Cooperative Governance for Women Board of Directors of Cooperatives and Rural Financing Institutions." Surat, from March 19 to 22, 2025. The programme aimed to empower women leaders in cooperative governance by focusing on best practices, decision-making strategies, and effective management techniques for cooperatives and rural financing institutions. Key dignitaries present at the inaugural session included: Shri G.H. Amin, Chairman, Gujarat State Cooperative Union, Mrs. Savitri Singh, Deputy Chief Executive, NCUI, Shri Rajender Tiwari, Chief Executive Officer, Gujarat State Cooperative Union and Dr. D. Ravi, Consultant, CICTAB. A total of 21 participants from Sri Lanka, Nepal, and India, including board members, CEOs, and senior and middle-level executives, took part in the programme. The event provided a platform for women leaders to exchange knowledge and experiences in cooperative governance.













6.3 As part of the commemorative activities for the International Year of Cooperatives 2025 (IYC 2025), NCUI, in collaboration with the CICTAB and VAMNICOM, successfully conducted an International Programme on "Training Techniques for Trainers of Cooperative and Rural Financing Institutions" from 27th to 31st January 2025 at VAMNICOM, Pune. The five-day programme aimed to enhance the training capacities of human resource development (HRD) personnel working in cooperative and rural development financing institutions across India and the SAARC region. A total of 24 participants, including 18 from Nepal and 6 from India, representing various cooperative training and financial institutions, took part in the programme.





- 7. Participation in Online/in-person International Seminars, Conferences, Workshops and Meetings
- 7.1 The General Assembly and Executive Committee (EXCOM) Meeting of the Network for the Development of Agricultural Cooperatives in Asia and the Pacific (NEDAC) was held in Mombasa, Kenya, from February 24 to 28, 2025. The event brought together leaders and experts from the cooperative sector across the Asia-Pacific region and Africa to deliberate on NEDAC's strategic direction and strengthen regional cooperation. Key discussions focused on strengthening agricultural cooperatives, promoting capacity building, and enhancing collaboration among member countries.







7.2 On 25th March, 2025 the Asian Farmers' Group for Cooperation (AFGC) conducted a hybrid Meeting, focusing on the theme "Decrease in the Number of Farmers and Measures to Secure Labour and Efficient Production." Mrs Savitri Singh, Deputy Chief Executive, NCUI, represented India at the meeting and presented the country paper, outlining key strategies and initiatives to tackle labour shortage and improve agricultural productivity. Her presentation emphasized on cooperative-driven solutions, technological innovations, and policy interventions that are crucial for ensuring sustainable agricultural growth in India. The AFGC meeting served as a valuable platform for member countries to exchange ideas, share best practices, and explore collaborative approaches to strengthen the agricultural sector in the face of workforce challenges.





7.3 Shri Dileep Sanghani, President, NCUI and Board Member, IRU, and Mrs Savitri Singh, Deputy Chief Executive, NCUI, attended the Virtual Meeting of the Board and Presidium of the International Raiffeisen Union (IRU) on March 24, 2025. IRU, a global association of national cooperative organizations, upholds Friedrich Wilhelm Raiffeisen's principles, fostering dialogue and knowledge exchange among members. In his address, Shri Sanghani praised the Raiffeisen Ambassador Training Programme, an innovative modular training initiative by IRU. He also highlighted key initiatives of the Indian Cooperative Movement for the International Year of Cooperatives 2025 (IYC 2025) and shared insights on India's vision for Viksit Bharat 2047, aiming for full development of the nation by its 100th year of independence.








7.4 ICA-AP Regional Office conducted ICA-AP Board Meeting and the IYC 2025 Regional Kick-off in Tokyo, Japan on 18th and 19th February 2025. The event was hosted by the Japanese Consumers' Co-operative Union (JCCU) and the Japan Co-operative Alliance (JCA). During IYC2025 Kick-Off meeting for Asia-Pacific, ICA-AP President Dr Chandra Pal Singh Yadav said that IYC2025 will position cooperatives as agents of inclusive growth. He called upon



all the apex cooperative organizations in every country to coordinate with the governments for setting up IYC 2025 coordination committee and also chalk out a calendar of programs to celebrate the IYC 2025 in a befitting manner. He pointed out that Hon'ble Union Minister for Home and Cooperation Shri Amit Shah recently inaugurated IYC2025 in India and a coordination committee of representatives of national and state level federations has already been formed to ensure that all the cooperative organizations are actively involved in the celebrations. Ministry of Cooperation in India has developed a 12-month calendar of programs to celebrate IYC 2025, aimed at expanding the cooperative sector, ensuring transparency, and enhancing inclusivity. The Deputy Chief Executive Mrs. Savitri Singh provided assistance to the President during the meetings.

- 7.5 Mrs. Savitri Singh, Deputy Chief Executive, NCUI, addressed a session titled "United Nations' Commitment to the Promotion of Cooperatives for Sustainable Development" on November 25, 2024. This session was part of the events leading to the official launch of the International Year of Cooperatives (IYC) and highlighted NCUI's pivotal role in the global cooperative movement. This prestigious opportunity reflected the significance of NCUI's contributions to the cooperative sector, both nationally and internationally.
- 7.6 ICA General Assembly of the International Cooperative Alliance (ICA) was held on 20 June via web conference, primarily to approve the 2023 Audited Accounts. The General Assembly was attended by the Dr Chandrapal Singh Yadav, President of ICA-AP & Vice President of ICA, NCUI President Shri Dileep Sanghani, Dr Sudhir Mahajan, Chief Executive of NCUI & Mrs. Savitri Singh, Deputy Chief Executive of NCUI. The Chief Executive participated as a designated voter from NCUI.





7.7 ICA-AP Regional Office and its Committee on Women in collaboration with the Vietnam Cooperative Alliance (VCA) organized the 'Asia-Pacific Women CEOs in Cooperatives Summit' from July 29-31, 2024, in Hanoi, Vietnam. The theme of the Summit was, 'Empowering Leadership: Navigating the Future of Cooperatives with Women at the Helm'. During the session, the Deputy Chief Executive Mrs Savitri Singh shared about her journey in the cooperative sector, the challenges and opportunities she witnessed for professional development and ensure a healthy work-life balance in her career. The Deputy Chief Executive also shared insights on how she ensured a healthy work-life balance; the challenges she faced and the steps she undertook for her professional development while juggling many roles and responsibilities, which was very beneficial for the participants at the summit.



7.8 The Vietnam Cooperative Alliance hosted the ICA-AP, Regional Board Meeting in Vietnam on 29th July 2024. Dr. Chandrapal Singh Yadav, President ICA-AP and Vice-President of ICA, and Mrs. Savitri Singh, Deputy Chief Executive of NCUI, participated in the meeting. The meeting had a strong focus on discussions related to revisions to the calculation of Membership Fees, allocation of voting rights to the members, and laying the ground-work for preparation of ICA -AP Strategic Plan for 2025-2030. Further, the discussions were aimed to provide a road-map for shaping the future of ICA as an institution, expanding its reach and ensuring its financial sustainability.





7.9 On 4th September 2024, International Cooperative Alliance – Asia Pacific (ICA - AP) convened the Introductory Webinar of Asia Pacific Cooperative Development Platform (APCDP). This platform is envisioned as a collaborative platform where cooperative development organizations (CDOs) from within and outside the region can come together. The primary objective is to facilitate knowledge exchange, mutual learning, and collective advocacy for cooperative development across the Asia-Pacific region. NCUI President Dileep Sanghani and NCUI Dy Chief Executive Savitri Singh attended this meeting. They discussed the background, overview of ICDP, scope and expectations from this platform.





7.10 The Organization of Brazilian Cooperatives (OCB) organized the International Seminar titled "Empowering Futures: Cooperatives at the Forefront of Inclusivity, Resilience & Environmental Stewardship" in Brasilia, held from 14th to 16th May 2024. Cooperative leaders, experts, researchers & senior government officials from 17 countries from Asia Pacific, Europe, Americas, Africa & UNDESA participated in this Seminar. Ariel Guarco, President of International Cooperative Alliance (ICA) inaugurated the Seminar. NCUI's Deputy Chief Executive shared her valuable insights & experiences as a speaker on the panel "Building Resilient Supply Chains through Cooperative Networks". Her session explored the critical significance of cooperatives in fortifying supply chains, promoting sustainability & facilitating international collaborations.





7.11 NCUI Participates in C7 Summit: On 14th & 15th May, C7 Summit was held in Italy. National Cooperative Union of India (NCUI) was represented by its officials Ritesh Dey (Executive Director), Sandhya Kapoor (Director) & Inderpreet Kaur (Assistant Director), who attended the Summit on virtual mode. The sessions covered topics such as interconnections & policy coherence for development, reforming the international tax & financial architecture, fostering peace building through economic justice & transformation, climate & energy transformation & environmental justice, global health, principled humanitarian assistance, common security & nuclear disarmament, migration & human mobility, & food justice & food systems transformation.





- 7.12 The International Cooperative Alliance (ICA) requested nominations for the prestigious Rochdale Pioneers Award, the highest honour bestowed by the ICA. The award recognizes individuals who, in the spirit of the Rochdale Pioneers, have made significant contributions to innovative and financially sustainable cooperative activities that have significantly benefited cooperative members. Nomination of Shri G.H. Amin, Member, Governing Council, NCUI, for ICA's Rochdale Pioneers Award 2024 was sent on behalf of NCUI.
- 7.13 The ICA Global Office organised a photo exhibition at the ICA Global Cooperative Conference. The exhibition was designed to showcase stories and experiences from around the world, highlighting how cooperatives have contributed to achieving prosperity for all. Member organizations of NCUI were invited to contribute images that capture the societal impact of cooperatives in India, in line with the theme "Cooperatives Build Prosperity for All." In response, photographs were received from SEWA, NFCSF, NAFSCOB, IFFDC, Gujarat State Cooperative Union, APCOB, LDB Bihar, and NCUI. These images, were shared with ICA for inclusion in the exhibition, highlight the cooperative movement's transformative impact on communities across India, demonstrating how cooperatives foster prosperity and improve lives.
- 7.14 Mr. Emanuele Cusa, a university professor and lawyer specializing in cooperative law, visited India in March 2025 to study the Indian cooperative movement and its legal framework. Mr. Cusa has been actively engaged in cooperative studies and practice since 1993, having completed his doctoral dissertation on financing members in cooperatives. Over the years, he has provided legal assistance to cooperatives across various sectors including banking, agriculture, energy, and social inclusion. He currently serves as a legal advisor to the Italian Ministry on cooperatives and has also been appointed by the European Commission as a legal expert on cooperative law. His deep expertise in the Italian cooperative system made his visit particularly valuable for fostering academic and institutional exchange between India and Italy. During his visit, Mr. Cusa expressed interest in meeting Indian university professors specializing in cooperative law to gain a comprehensive understanding of the legal and regulatory framework governing cooperatives in India. The International Relations Division successfully coordinated his visit and facilitated meaningful engagements. Mr. Cusa expressed his sincere appreciation for the support and guidance extended to him during his stay in India.

CHAPTER 7

COOP CONNECT

The National Cooperative Union of India (NCUI) has constituted a special cell, "Coop Connect," to orient school and college students to the cooperative philosophy and demonstrate how they can benefit by creating employment opportunities for themselves as well as others by forming and running their own cooperative societies. Special modules explaining the basic concepts of cooperative management are provided to enable them to grasp the distinctive features of this sector, appreciate its contribution to the national economy, and understand successful cooperative business models.



The objective of the Coop Connect division is to popularise and raise awareness of cooperatives among youth. The division has conducted 31 activities and webinars with 3,332 participants from all over India. It conducts various types of activities. The flagship program of the division is titled "Successful Cooperative Business Model." This program is conducted in various modes — online, offline, and hybrid. Apart from the flagship program, the Coop Connect division has also organised several competitive events, including drawing competitions, debate competitions, essay writing, cooperative quizzes, and more. More than 259 students from different universities and schools participated during the Cooperative Fair, held from 24th to 27th October 2024.

As part of the UN International Year of Cooperatives 2025 (IYC2025), NCUI, has organized a series of one-day, state-level youth workshops titled "Cooperative Olympiad" across all states and union territories. These workshops aim to educate and engage students through training sessions on cooperative basics, career and entrepreneurial opportunities, and interactive events like quizzes, essay writing, debates, and extempore competitions.











Winners from each state will qualify for the **National-Level Cooperative** Olympiad to be held in **November or December 2025** in New Delhi. They will be felicitated with trophies and certificates by the Hon'ble Chief Guest during the **National Cooperative Conference**, marking the grand finale of **IYC2025** celebrations.









Over the course of the year, the Coop Connect Division trained students from various institutions, including Management institutes, Central and State Universities, Public Schools, DAV Schools, Government Schools and Kendriya Vidyalayas.

The Coop Connect division of NCUI has achieved significant milestones. In addition to training thousands of students, the division has expanded its presence across numerous states in India. These include Assam, Gujarat, Karnataka, Manipur, Andaman & Nicobar Islands, Himachal Pradesh, Uttar Pradesh, Delhi (NCR), Haryana, Meghalaya, Rajasthan, Odisha, Punjab, Chhattisgarh, Andhra Pradesh, Madhya Pradesh, and Nagaland.



The cell provides information and raises awareness about various areas related to cooperatives and the initiatives undertaken by NCUI and the Ministry of Cooperation. The programs cover topics such as:

CHAPTER 8

NATIONAL COOPERATIVE DATA BANK

During the year 2024-2025, the NCDB Division played an active role in various initiatives, making significant contributions to the development and maintenance of the National Cooperative Database (NCD) portal.

Communications and Coordination with Ministry of Cooperation and Other Stakeholders for NCD Portal Maintenance and Development:

Throughout the year, the NCDB maintained consistent communication with the Ministry of Cooperation (MoC) concerning fund releases, audited utilization certificates, proforma invoices, and UTR details. The NCDB ensured timely updates with the Ministry about work orders for producing films related to the NCD, printing arrangements for the NCD report, billing issues with vendors, and fund releases to NICSI for technical staff engaged through the Cooperative Education Fund (CEF). Additionally, the Head of the NCDB Division was appointed as the nodal officer for all NCD portal-related matters, which helped streamline communication and oversight.

Data Compilation, Analysis, Reporting, and State/Sectoral Cooperative Profiles:

The division has compiled comprehensive cooperative data from fifteen societies and sectors, which have been categorized into top, mid, and lower levels based on key metrics such as membership, turnover, capital, and profit. In addition, detailed profiles of the Cooperative Movement in states such as Rajasthan, Ladakh, Jharkhand, Tripura, and Sikkim were prepared to assist with seminars and GCP meetings organized by the NCUI.

A concise overview of Consumer Cooperatives in India was prepared for an NCUI official attending the International Training Program on "Management Strategies to Develop Consumer Cooperatives" organized by CICTAB-NCC-VAMNICOM. Two comprehensive presentations were developed on the Sikkim Cooperative Movement and the combined activities of the NCUI divisions for the period of 2024–2025, for the Board meeting, which was held in March 2025 at Sikkim.

Data was also collected to conduct a comprehensive risk analysis of government entities and cooperative organizations, as directed by the Director General of Audit, New Delhi. Updated sector-wise and membership-wise cooperative data were compiled, based on Indian Cooperative Movement Statistical Profile 2018, and shared with the International Cooperative Alliance Asia-Pacific (ICA-AP) and Ministry of Cooperation. The division also compiled and updated data on district-level federations and unions, which was submitted to the Ministry. The division updated information on cooperatives' contribution to India's economy for the year 2023. This update was based on the 2018 Statistical Profile of the Indian Cooperative Movement.

Further, the division analysed the coverage and gaps in the Primary Agricultural Credit Societies (PACS), Dairy, and Fishery sectors at the Gram Panchayat level, and submitted these findings to the Ministry.



Responses to Parliamentary and RTI Queries:

The NCDB division provided inputs/ responses to parliamentary questions concerning the cooperative sector, including questions about national cooperative data, digitalization efforts, and sector-specific statistics. Inputs for RTI applications related to directives issued to Registrars of Cooperative Societies and Data entry personnel were compiled and submitted to the Ministry.



CHAPTER 9

NATIONAL COOPERATIVE RESOURCE CENTRE AND COOPERATIVE EXTENSIONS AND ADVISORY SERVICES

I. National Cooperative Resource Centre (NCRC)

In alignment with the visionary directives of the Hon'ble Union Minister of Home Affairs and Cooperation, the National Cooperative Union of India (NCUI) established the National Cooperative Resource Centre (NCRC) in December 2022. This initiative, following the landmark guidance issued on 1st September 2022, is a significant step in strengthening the institutional, policy, and intellectual foundations of the Indian cooperative movement. As a national-level think tank, the NCRC aims to reinforce cooperative research, strengthen policy frameworks, and build institutional capacities across all levels of the cooperative ecosystem.

Since its inception, the NCRC has actively initiated a series of transformative efforts in the areas of training, research, and sectoral engagement. Central to these efforts is the development of a comprehensive set of **28 training modules** designed to address both institutional and business dimensions of cooperatives. These modules are being developed under two thematic pillars: **"Cooperative as an Institution"**(11 modules) and "Cooperative as a Business Enterprise" (17 modules). The goal is to empower cooperative personnel, leadership, and members with targeted knowledge that enhances governance, compliance, operational efficiency, and business competitiveness.

Under the first theme, "Cooperative as an Institution," 6 out of the planned 11 modules have already been finalized and published. These include essential topics such as Community Mobilisation and Registration of Cooperatives, Business Development Planning, Members' Role in Cooperatives, Governance, Legal Compliances, and Auditing of Cooperatives. The remaining five modules—covering Management, Accounting, Financial Management, Implications of GST, and Implications of Income Tax—are currently under development and are expected to further deepen the institutional capabilities of cooperatives.

The second thematic area, "Cooperative as a Business Enterprise," focuses on strengthening sector-specific knowledge and entrepreneurial strategies across various cooperative sectors. Of the 17 planned modules in this domain, 7 have been finalized and published, 2 are ready for publication, and the remaining 8 are currently under review by the respective national federations and cooperative societies to ensure they are sectorally accurate and contextually relevant. These span key areas such as Primary Agricultural Credit Societies, Rural Cooperative Banks, Urban Cooperative Banks, Credit, Fisheries, Marketing, Housing, Health, Dairy, Sugar, Consumer, Labour, Handloom, Handicrafts, Organic, Seed, and Export Cooperatives.

























These modules are also accessible through NCUI's CEAS-LMS platform, enabling wider and scalable digital outreach.

Through these initiatives, the NCRC is gradually emerging as a centre of excellence for cooperative education and policy advisory. The Centre not only supports capacity building at the grassroots but also provides a structured platform for standardizing and upgrading cooperative training nationwide. Through the fusion of academic expertise and practical sector-specific insights, the NCRC is helping transform cooperatives into dynamic, resilient, and professionally managed institutions.

II. Cooperative Extension and Advisory Services (CEAS)

In response to the directives issued by the Hon'ble Union Minister of Home Affairs and Cooperation on 1st September 2022, the National Cooperative Union of India (NCUI) established the Cooperative Extension and Advisory Services (CEAS) Division in December 2022. CEAS works as the outreach and implementation arm of NCUI, helping to strengthen and support Cooperative Extension Institutions like State Cooperative Unions (SCUs) and Junior Cooperative Training Centres (JCTCs). Its mission is to reinforce and deepen the cooperative movement through a multi-dimensional strategy encompassing capacity building, advisory services, research, awareness generation, and the promotion of new and existing cooperatives.

A key highlight of CEAS's initiatives is the development and expansion of the CEAS-LMS Portal (https://ncuicoop.education), a Learning Management System (LMS) platform created to provide cooperative education to a wide and diverse audience efficiently. The portal integrates four major components: the Learning Management System (LMS) that offers structured courses and certification; the Cooperative Resource Center (CRC) for collaboration and knowledge sharing; the Query Management System (QMS) for Frequently Asked Questions (FAQs), expert guidance and query resolution; and interactive e-courses tailored for remote and professional learners. As of March 31, 2025, the platform has attracted 1,468 registered users, 82,600 visitors, 1,094 course enrollments, and 215 course completions, marking a significant rise in digital adoption within the cooperative sector.

To drive engagement on the portal, NCUI has undertaken comprehensive promotional campaigns through its official social media handles on Facebook, Instagram, and LinkedIn. The CEAS-LMS Portal is routinely introduced in NCUI's training programmes, particularly by the National Centre for Cooperative Education (NCCE), where live demonstrations are conducted. Additionally, the CoopConnect Programme, designed to engage youth in cooperative education, has incorporated



CEAS-LMS Portal awareness sessions to ensure outreach to a younger demographic. These collective efforts have significantly enhanced visibility and adoption of the platform across various user groups.

CEAS has actively expanded its academic outreach by conducting "Orientation cum Awareness Generation" sessions at institutions such as Birsa Agriculture University, Kerala State Agricultural University, and Sri Balaji University. It also introduced the certificate programme "Coops4SRD: Sustainable Rural Development" tailored for agriculture and agribusiness management students, with two successful batches held in March 2024 and 2025.

To engage youth, the Coops4GenNext Knowledge Series was launched on World Youth Skills Day 2023, featuring expert-led sessions on cooperative innovations, PACS diversification, and millet promotion. Sector-specific webinars and Training of Trainers (ToT) Programmes have also enhanced cooperative capacity in areas like housing and PACS transformation.

To ensure regional accessibility, CEAS is working towards developing the training modules in 12 vernacular languages i.e. Hindi, Marathi, Gujarati, Bengali, Kannada, Assamese, Tamil, Odia, Telugu, Malayalam, Punjabi, Manipur/Maiti. Currently, CEAS has developed PACS course content in Hindi and Marathi, covering governance, finance, marketing, and diversification. The division also launched fee-based e-courses through the LMS portal, including "Management of Cooperative Housing Societies" and "Election for E-type Cooperative Housing Societies," in collaboration with the Maharashtra State Cooperative Housing Federation.

Further strengthening its training mandate, CEAS introduced new training programmes sponsored by the Ministry of Cooperation under the Cooperative Education Fund (CEF), aimed at enhancing the capabilities of Cooperative Information Officers (CIOs) and Non-Credit Multi-State Cooperative Societies (MSCSs).

Through its wide range of activities, the Cooperative Extension and Advisory Services (CEAS) Division is playing an important role in strengthening cooperative education and outreach in India. Through digital platforms and collaboration with training institutions and youth, CEAS is empowering cooperatives to become more informed, skilled, and prepared for future challenges.









CHAPTER 10

NCUI HAAT

NCUI HAAT is a novel initiative taken by National Cooperative Union of India (NCUI) to empower lesser known Cooperative and Women Self Help Groups. It is a connecting bridge between people of Delhi, the Artisans and Craftsmen from rural India. The COVID-19 pandemic has adversely impacted a section of smaller enterprises and cooperatives and they are struggling to run their businesses. Many of these societies don't have access to large markets due to financial constraints, lack of proper training and experience. To help such enterprises cope with the difficult times, the NCUI HAAT initiative has been conceived, to assist women to led and lesser known cooperatives, by providing them a stall space for their products at an exhibition-cum-sale centre named 'NCUI HAAT' in its premises located at a premium location in Delhi.

Though this initiative is for the self-help groups of NCUI Education Field Projects, to expand the landscape of Indian Cooperative Movement, other self-help groups, specifically women groups are also being given an opportunity to benefit from this novel initiative.

Since its inauguration on 16th August, 2021, NCUI HAAT has received overwhelming response from the visitors, residents of Delhi and employees working in the nearby institutions.

- To support a circular economy and promote the use of healthy and eco-friendly products in urban classes.
- To support traditional artisans and craftsmen by promoting use of their products at national level events
- To identify products of the Cooperative for GI Tagging.
- To identify members of lesser known cooperatives and SHGs for training and skills development as well as enhancement of quality and grade of their products.



KEY FEATURES

- The visitors are able to see a large variety of products which are handmade with locally available material of that area.
- Exhibition cum stall space is provided free of cost to the participating groups.
- To provide an equal opportunity to the needy SHGs and Coops, a calendar is being followed where products of 5-6 states are exhibited for 15 days and new groups are given an opportunity thereafter.

NCUI HAAT ACTIVITIES

On every 15-20 days cycle of products from NCUI Education Field Projects and Cooperatives/ SHGs of 5-6 states are invited for display and sale, accordingly advertisement & information about new arrivals are shared via social media platforms like Facebook, Twitter and banners.

Participation in Exhibition at Kirorimal College:- On 8th May 2024, the Entrepreneurship Cell of Kirorimal College (KMC), University of Delhi, in collaboration with the National Cooperative Union of India (NCUI), organized a special exhibition. Cooperatives and self-help groups associated with NCUI Haat and the NCUI Incubation Center showcased a range of authentic handmade products, reflecting the rich diversity of Indian craftsmanship.

NCUI faculty and staff briefed students and visitors about the new initiatives taken by the Ministry of Cooperation. The event highlighted the active participation of women and local artisans, while promoting cooperative models as effective tools for entrepreneurship and social development.

Participation in 'Nav Ras' Exhibition Organized by COWE Haryana:- From 3rd to 5th August 2024, NCUI Haat and the NCUI Incubation Center participated in the 'Nav Ras' exhibition organized by the COWE Haryana Chapter at The Apparel House, Gurugram. The Rakhi Bazaar served not only as a vibrant trading platform but also as an opportunity to highlight the role of cooperatives and SHGs in preserving traditional arts and crafts.

NCUI Haat Celebrates 3rd Foundation Year on 16th August 2024: On 16th August 2024, NCUI Haat celebrated three successful years of uniting lesser known Cooperatives/ SHGs/ Artisans from across India and showcasing the Indian rich cultural heritage. Over the past three years, this vibrant platform has emerged as a significant promoter of tradition, creativity, innovation, and sustainable practices, featuring a wide range of handmade products—from handwoven textiles to intricate crafts.

Dr. Sudhir Mahajan, Chief Executive, NCUI, along with other senior officials, graced the occasion and acknowledged the remarkable progress achieved by NCUI Haat. The event emphasized the critical role of NCUI Haat in empowering local artisans and promoting sustainable marketing practices. 

CHAPTER 11

CENTRE FOR ENTREPRENEURSHIP DEVELOPMENT & COOPERATION (CEDC)

A. Research and Development

- i. CEDC has developed a comprehensive Action Plan to plan implement various interventions for the International Year of Cooperatives - 2025
- ii. Through the series of initiatives and projects being planned in IYC-2025, we aim to empower over 10,000 collectives (SHGs/Cooperatives/FPOs) and touch the lives of over 60,000 individuals.
- iii. To kick off the Action Plan for the International Year of Cooperatives (IYC) 2025, CEDC organised the first meeting of Committee of Women Entrepreneurs (CoWE) under the chairmanship of Dr. Sudhir Mahajan, Chief Executive of NCUI on 2nd January 2025. 20 pass-out trainees turned entrepreneurs of Incubation Centre have become members of COWE.



iv. CoWE has been established by CEDC to identify and address the challenges faced by women SHGs, develop effective models of cooperative entrepreneurship, and provide training to empower other women in Delhi and other states.

B. MoUs and Collaborations

i. NCUI signed MoUs with GIZ India, Ladakh Autonomous Hill Development Council (LAHDC), Handicrafts and Carpet Sector Skill Council (HCSSC), National Consumer Cooperative Federation (NCCF), Alliance for Energy Efficient Economy, Dattopant Thengdi National Board for Workers Education Development (DTNBWED), T.A. Pai Management Institute (TAPMI), Bangalore and Tantia Group, Ganganagar.

- i. GIZ India has engaged ISRA to establish a Project Management Unit (PMU) at NCUI for 17 months till February 2026. This PMU has been set up to oversee the activities, objectives, and requirements of CEDC.
- ii. Through the PMU, NCUI has selected over 30 locations in 15 states to execute pilot projects in the areas of cooperative development and women's livelihoods.



iii. From September, 2024 to March, 2025, CEDC has provided training on digital literacy and social protection schemes to over 10,000 individuals and over 300 SHGs and cooperatives have been adopted under the project.






 AOL is working closely with NCUI to register over 500 multi-purpose cooperative societies in five states. Over 120 multi-purpose cooperative societies have applied for registration in Karnataka in 2024.

C. NCUI HAAT E-COMMERCE PORTAL

NCUI Haat e-commerce portal, a first-of-its-kind portal exclusively for cooperative societies
was launched by Hon'ble Prime Minister for National Capital Region on 1st July, 2023 during
the Indian Cooperative Congress event.



- The coverage network of NCUI Haat portal was expanded to pan-India level in March, 2024.
 More than 2000 cooperatives and SHGs have been onboarded on the portal since December, 2024.
- NCUI Haat Cooperative Fair organized every year during Cooperative Week to promote handcrafted products of cooperatives.

D. NCULINCUBATION CENTRE

- Over 500 women have been empowered through various training programs of Incubation Centre in 2024-25.
- A majority of the trainees have updated their ID documents and got enrolled for ABHA, MSME, FSSAI and other social welfare schemes. This has resulted in saving of over 15,000 per trainee and all the trainees have got an insurance cover of Rs. 2 lakhs under Suraksha Bima Yojana.
- Resource Persons of the Incubation Centre project are now being engaged by SULM and reputed social organizations for providing training to their target population.
- 'Coop Kitchen' project of CEDC has proved to be a successful livelihood model for women and many renowned organizations like HCL Foundation have engaged them to provide catering



services during their events.

E. NCUI SKILL DEVELOPMENT CENTRE

- Art of Living organization has setup training infrastructure through Schneider Electric, Jaguar, Godrej, Supertronics, NASSCOM, etc. under CSR to provide training in solar technician, electrician, plumbing, mobile repair, etc.
- HCL Foundation has setup training infrastructure at the centre through its reputed training partners like ACCESS, Udayan Care, EFFRAH and Katha to provide training in stitching, embroidery, bakery, desktop publishing, graphic design, accounting, etc.
- HCL Foundation has initiated a Women Mobility Program under which 30 e-rickshaws have been procured in the first phase which will be operational in and around NCUI Skill Development Centre. This intervention aims to promote women mobility and make the Centre easily accessible for the trainees.
- Orion International, a global manpower service provider company, has approached NCUI for organizing a job fair at SDC wherein candidates skilled in facility management, nursing, driving, etc. will be interviewed and placed in reputed companies based in India and other countries.
- In addition to the vocational training programs being run by partner institutions, the participants are also provided training on digital literacy, financial inclusion, formation of cooperative societies, etc. under the Incubation Centre project of CEDC.



CHAPTER 12

REPORT OF MEMBER INSTITUTIONS

INDIAN FARMERS FERTILISER COOPERATIVE LTD. (IFFCO)

Indian Farmers Fertiliser Cooperative Ltd., known as IFFCO, is a Multi-State Cooperative Society, wholly owned by Cooperatives. Established on November 3rd, 1967, with a modest share capital of ₹ 5.5 Lakh and 57 member societies, it has undergone remarkable expansion. Presently, it serves an extensive network of 35,675 member societies and has augmented its share capital to 629.06 Crore.

Following the constitution of the 15th Representative General Body (RGB), a new Board of Directors has been successfully constituted at IFFCO. The election for the new Board was conducted smoothly and transparently under the supervision of the Cooperative Election Authority appointed by the Central Government.

For the first time in its 130-year history, the International Cooperative Alliance (ICA) General Assembly and Global Conference was hosted in India. IFFCO organised this landmark event in collaboration with the ICA and the Ministry of Cooperation, Government of India. UN International Year of Cooperatives (IYC) 2025 was officially launched by the Hon'ble Prime Minister Shri Narendra Modi at the ICA Global Cooperative Conference. Marking a proud milestone, the Managing Director of IFFCO, Dr. U.S. Awasthi, was conferred the Rochdale Pioneers Award—the highest honour bestowed by the ICA—during the conference, in recognition of his exceptional contribution to the cooperative movement.

The ICA event was thoughtfully designed to be both carbon-neutral and paperless. To offset its carbon footprint, 10,000 Peepal trees were planted across different parts of the country. Additionally, all event components—including fabrication, conference kits, bottles, and other materials—were created using environmentally friendly and sustainable resources. The event was kept alcohol free with an exclusive serving of vegetarian foods.

Building on this spirit, IFFCO has rolled out its Action Plan for IYC 2025, focusing on key initiatives to strengthen cooperative engagement and sustainability. A key priority is the membership drive, aimed at expanding the participation of cooperative societies.

To support global climate action, IFFCO has launched a tree plantation drive, planting 10 lakh trees across the country to offset carbon emissions from its employees and production units. The goal is to become a "Carbon Neutral Cooperative" during IYC-2025, underscoring our commitment to environmental conservation and sustainability.

In April 2025, IFFCO's Kalol Unit completed 50 years of successful operations. On this Golden Jubilee of the Kalol Plant, a special event was organized by IFFCO where the Hon'ble Minister of Home and Cooperation, Shri Amit Shah, rededicated this Unit to the farmers of the Nation to mark the International Year of Cooperatives.



IFFCO has added new products along with Nano Urea Plus and Nano DAP like Nano NPK, Nano Zinc and Nano Copper. IFFCO's Mega Campaign for the Promotion & Application of Nano Fertilisers has further accelerated farmer engagement through the IFFCO Model Nano Village/Cluster initiative. IFFCO's total production of fertilisers in FY 2024-25 was 93.10 lakh metric tonnes with total sales of 113.78 lakh metric tonnes. IFFCO's Profit before tax increased from ₹3,234 crore to ₹3,811 crore in FY 2024-2025, while profit after tax stood at ₹2,823 crore, up from ₹2,443 crore in the previous year. Nano fertiliser production reached 456.93 lakh bottles, with 364.28 lakh bottles sold during the year, which was the highest sales recorded for the year 2024-25.

COOPERATIVE AND RURAL DEVELOPMENT THROUGH VARIOUS INITIATIVES

IFFCO in its efforts towards rural and cooperative development, continues to fulfill Corporate Social Responsibility through its promoted organisations / different programmes such as:

- IFFCO Kisan Sewa Trust: a charitable trust created out of joint contribution from IFFCO & its
 employees to provide relief and rehabilitation to the victims in the event of natural calamities.
 During the year under review, the Trust spent ₹ 86,43,000 towards critical medical assistance
 to patients, ₹ 50,25,000 towards scholarships to the students belonging to the families of small
 and marginal farmers.
- Indian Farm Forestry Development Cooperative Limited (IFFDC): IFFCO promoted a separate
 multi-state cooperative society with the prime objective of conserving the environment and
 mitigating climate change through sustainable natural resource management for enhancing
 the socio-economic status of rural poor, tribal communities, and women in particular. IFFDC
 promoted 50 FPOs with 24,183 members and also distributed hybrid vegetable seeds of
 different crops to farmers. For women empowerment, IFFDC nurtured 1,914 Self Help Groups
 (SHGs) out of which 94% were women members.
- Cooperative Rural Development Trust (CORDET): has been promoted by IFFCO to promote rural
 development. It is engaged in providing training to farmers on various aspects of farming,
 innovative technologies, soil testing and animal husbandry. During the year under review,
 172 farmer's training programmes benefitting 9,783 farmers including women farmers, were
 organised through the trust. Also, 197 social development programs were held in 25 adopted
 villages, engaging 7,597 people.
- Farmers Extension Activities: Various promotional and extension programs on the latest Agritechnology were organised with farmers for balanced use of bio fertilisers, agro chemicals etc. to enhance crop productivity through efficient use of fertilisers, water conservation etc.
- Village Adoption Programme: The village adoption program was initiated by IFFCO with the
 objective to bring about overall socio-economic development in villages for sustainable
 agriculture development with particular emphasis on balanced use of fertilizers, quality seeds,
 and better farm management. Various promotional, social and community development
 programs, medical and veterinary check-up campaigns, training programs for rural women
 etc., were organized in 241 adopted villages during the year under review.

NATIONAL FEDERATION OF STATE COOPERATIVE BANKS LTD. (NAFSCOB), VASHI, NAVI MUMBAI

1. Introduction:

National Federation of State Cooperative Banks Ltd. (NAFSCOB) was established on May 19, 1964 with a broad objective to facilitate the operations of State and Central Cooperative Banks, in particular and development of Short Term Cooperative Credit & Banking in gen-eral. NAFSCOB is registered as a national level cooperative society under Multi-State Coop-erative Societies Act, 2002 (Amended). NAFSCOB completed about 62 years of its useful services to the rural cooperative credit delivery system. NAFSCOB provides common forum to its members and their affiliates/shareholders/owners to project their achievements, focus their concerns and promote their interests. As at the end of March, 2024, there are 34 State Cooperative Banks (SCBs) of which 33 are members of NAFSCOB, with a network of 2241 branches, 351 District Central Cooperative Banks (DCCBs) with 14228 branches and 107641 Primary Agricultural Credit Societies (PACS).

2. Divisions of NAFSCOB:

NAFSCOB operates with three important Divisions, viz. (1) Planning, Research and Devel-opment (PRD) and (2) Computer Services Division (CSD).

Membership in NAFSCOB: The membership of NAFSCOB is open to all the SCBs in the Re-public of India. At present 33 SCBs are members of NAFSCOB and 37 DCCBs are Associate Members of the NAFSCOB.

3. Performance of NAFSCOB:

NAFSCOB with its limited resources, both financial and manpower, accomplished its tasks exceedingly well in achieving the spelt out objectives. The performance of NAFSCOB during the last Seven decades may be categorised as under:

NATIONAL COOPERATIVE HOUSING FEDERATION OF INDIA

The National Cooperative Housing Federation of India (NCHF) is a nation-wide organization of the cooperative housing sector. The primary objective of NCHF is to promote housing cooperatives and to coordinate and facilitate their operations especially the Apex Cooperative Housing Federations (ACHFs) which are its members. The main activities and achievements of NCHF during the year 2024-25 are given below:

PROMOTIONAL ACTIVITIES

- 1. NCHF makes efforts to promote ACHFs in those States where such organizations do not exist and to strengthen the ACHFs which are comparatively weak. During the period under reference two new State Cooperative Organisations were admitted as members of NCHF and efforts are being made to further increase the membership of NCHF. All necessary support and cooperation was provided to Member ACHFs on various issues. Important publications/documents were also circulated to them at regular intervals.
- 2. A brief note on suggestions for framing Guidelines of Cooperative Rehabilitation, Reconstruction and Development Fund (CRRDF) was sent to the Office of the Central Registrar of Cooperative Societies (CRCS), Ministry of Cooperation.
- 3. Properties of housing cooperatives got insured through NCHF. Member ACHFs and primary housing cooperatives were requested to cover their housing projects under the 'Bharat Griha Raksha Policy' through NCHF at reduced premium. Necessary guidance was also provided to housing cooperatives and other concerned regarding general insurance of properties.

To commemorate the International Year of Cooperatives-2025 (IYC-2025), the Handouts on Cooperative Housing namely 'National Development through Housing Cooperatives' and 'Sahakaritao Ke Maadhyam Se Awas' in Hindi were brought out for the benefit of members of housing cooperatives. The Handouts were circulated to Members of the Board of Directors of NCHF, all Managing Directors of Apex Cooperative Housing Federations, President/Secretary of



District Cooperative Housing Federations and Primary Housing Cooperatives. They were also requested to celebrate the IYC-2025 and increase visibility of Housing Cooperatives and raise public awareness. The Handouts contains brief details on the role, growth, distinctive features of housing cooperatives and code of conduct for members of housing cooperatives as well as benefits, rights and duties of members, etc. (in Hindi).

NCHF conducts Research and Studies and compiles information/statistical data for the benefit and use of all concerned engaged in cooperative housing activities. The Registrars of Cooperative Societies (RCS) of concerned States were requested to send information/data on the operations of housing cooperatives in their respective States. Data regarding NCHF and its Member ACHFs was also entered on the National Cooperative Database Portal of the Ministry of Cooperation.

CONFERENCES/WEBINARS

NCHF has been organizing conferences/workshops/study visits/webinars etc. for the personnel of ACHFs and housing cooperatives and also representing cooperative housing sector in such events. Such forums are organized or attended to facilitate personnel of housing cooperatives working at various levels to gain exposure to best practices as well as to review the progress and discuss various problems faced by housing cooperatives so as to suggest measures for their smooth functioning.

To commemorate the Cooperative Week Celebrations-2024, NCHF brought out a special issue of 'NCHF Bulletin' which was released by Shri Dileep Sanghani, Ex-MP and Ex-Minister, Government of Gujarat and President, National Cooperative Union of India (NCUI) at the inaugural function of the Cooperative Week Celebrations organized by NCUI on 14th November, 2024. The above publication was circulated among the participants of the inaugural function. On this occasion, an E-Course on the Management of Cooperative Housing Societies was launched on CEAS-LMS Portal of the NCUI. Shri N.S. NATIONAL COOPERATIVE DAIRY FEDERATION OF INDIA LIMITED

Overview

NCDFI, with its core objective of supporting dairy cooperatives through networking, coordination, and policy advocacy, consistently made efforts to create value for its members. During 2024-25, NCDFI continued to play a pivotal role in coordinating the supply of milk and milk products to esteemed institutional buyers such as the Indian Army, ITBP, and others. The Federation also facilitated transparent and efficient online transactions through the NCDFI eMarket, supported the genetic improvement of dairy animals, and undertook capacity-building initiatives for stakeholders. Surplus funds were effectively utilised for developmental activities, ensuring sustainable growth and strengthening of the cooperative dairy sector.

Institutional Sales

NCDFI coordinated the supply of milk and milk products to 348 Army Supply Depots, 45 Air Force Stations, 8 Naval Units, and 14 ITBP Battalions, valued at ₹1,559 crores. The effort involved 115 dairy cooperatives across the country supplying the milk and milk products, and with brands such as Amul, Mahanand, Nandini, Saras, Verka, Visakha, and Warana providing UHT Milk.

NCDFI eMarket Operations

- Conducted 16,450+ eAuctions across commodities and services.
- Traded 50,693 MT SMP, 17,765 MT Butter, 1,361 MT WMP, 608 MT Ghee, 910 MT Whey Powder, 340 MT Cheese, and 8.89 lakh litres RCM.
- Facilitated procurement for 54 cooperative cattle feed plants in 18 States/UTs, trading over 6 lakh MT of feed ingredients (maize, DORB, rice bran, mustard meal, etc.).
- Total transactions: ₹4,480 crores (Dairy products ₹2,031 cr, Cattle feed ₹1,543 cr, Packaging ₹340 cr, Sugar ₹92 cr, Misc. ₹474 cr).

(NYCS Ltd.) is multistate, multipurpose cooperative society which works towards making the youth economically independent by engaging them in various employment or self- employment related activities. The organization was formed in 1999 and registered under the section 7 of the Multi-state Cooperative Societies Act 1984. The main activities of NYCS are Micro Finance, facilitating youth, creating self- help groups, entrepreneurship development and capacity building of youth and other stakeholders for their economic empowerment.

Since its inception, NYCS Ltd. has been focusing on developing and nurturing entrepreneurs across India. NYCS Ltd. has a strong network in 603 districts across India. The beneficiaries are identified and are given entrepreneurship training which includes bookkeeping, marketing skills, soft skills, managerial skills, team management, leadership management, and life skills.

Annual Performance Report: Micro FinanceDivision (2024-25)

The financial year 2024-25 has been a landmark year for the Micro Finance Division of National Yuva Co-operative Society Limited, characterized by robust growth, strategic expansion, and enhanced service delivery. This report presents a detailed overview of our achievements, operational performance, and future outlook.

Financial Performance

The division recorded exceptional financial results during the reporting period. We mobilized total deposits worth ₹95.87 Cr, This growth was achieved through our expanding depositor base. On the lending front, we disbursed loans totalling ₹62.90 Cr. across various products.

Future Roadmap

Looking ahead to 2025-26, we have set ambitious targets across all operational areas. Our expansion plans include opening five new branches with the goal of reaching a total network of 41 locations by the fiscal year-end.

Financially, we aim to achieve ₹ 150 Cr. in deposit mobilization and ₹ 105 Cr. in loan disbursements, with a special focus on growing our Gold Loan portfolio to ₹ 9 Cr.

At present, Jananidhi is actively running 35 centres across 5 states and 2 Union Territory, helping to strengthen local economies and create livelihood opportunities. So far, it has distributed over ₹ 22,93,70,878/- in loans, directly benefiting more than 1624 individuals across the country.

Guided by the vision "Samartha Yuva, Samarth Bharat," NYCS has been working since its inception to provide young people with opportunities through skill development, vocational training, healthcare, sports, and entrepreneurship.

Rural Homestays Transform Tribal Villages in Madhya Pradesh

Eight new homestays were inaugurated in Bacha and Bajjarwada villages of Betul district as part of a rural tourism initiative by the Madhya Pradesh Tourism Board, in collaboration with NYCS team and Back to Village (B2V). The initiative aimed at generating employment in tribal areas, this project offers 40–60% government subsidies and promotes cultural tourism through folk music, bullock cart rides, agricultural activities, and rural sports. Built with traditional mud architecture and surrounded by green fields, the homestays provide a unique rural experience with modern facilities limited to bathrooms. Guests enjoy organic food from kitchen gardens, cooked on earthen stoves, and participate in local farming, festivals, and cow care.

Women are at the centre of this initiative, running the homestays and becoming financially self-reliant. Each village has a tourism committee to manage bookings and ensure visitor comfort. A



major highlight was the overnight stay of Union Minister of State for Tribal Affairs, Durgadas Uikey, who experienced the homestay first-hand, interacted with villagers around a campfire, and praised Bacha village for becoming the first in India with solar-powered kitchens. He urged people to visit and support this model of sustainable rural tourism.

Mission and Outreach

Prerana Multistate Urban Co-op Credit Society (Ahmednagar) remained focused on its mission of serving rural and underserved communities by providing accessible financial services. The Society operated a stable network of 7 branches during 2024—25, reaching a membership of 5,845 individuals. Plans are underway to expand into more rural areas to deepen outreach, reflecting the Society's commitment to needy and underdeveloped regions. Community-centric Initiatives were a priority — the Society organized financial literacy drives, health and blood donation camps, educational support for members' children, and women's empowerment sessions supporting self-help goups (SHGs), in line with its cooperative ethos.

Financial Performance

Despite a challenging economic environment, the Society achieved robust gowth in the 2024–25 financial year. Total deposits grew from ?67.18 crore to ?77.54 crore (as of March 31, 2025), while total advances increased from æ45.04 crore to Z54.24 crore, indicating strong credit expansion to members. Net profit after tax rose notably, from ? 10.49 lakh in the previous year to Z 17.68 lakh in 2024–25. These gains were supported by steady operational effciency and prudent financial management. The Society's share capital and reserves also strengthened, and the branch network remained at seven, ensuring continuity of services across its areas of operation.

Technological Advancements

To improve member services and operational efficiency, Prerana upgraded its core banking system and technology infrasüucture during the year. A new Core Banking Solution (CBS) was implemented for faster, more rebiable service delivery. The Society also introduced SMS alert services and e-passbook facilities to enhance communication and transparency for members. Notably, a mobile banking app is under development to offer convenient digital access to accounts and transactions. These technology initiatives have strengthened cybersecurity and positioned the Society to meet modem banking expectations of its members.

Governance, Cotnpliance & Reserves

Society maintained statutory cotnpliunce, timely audits, and appropriations of profits toward reserves, education, and dividend distribution.

Chairman Shri Sujit Suresh Wable remarked that FY 2024—25 was a year of growth and recognition. adding:

"Our is committed to serving rural and needy communities with modern financial solutions while staying rooted in cooperaff,/e values." and the audit report and financial statements were submitted promptly to the Central Re\$sü-ar of Co-operative Societies. Prerana maintained an "A" audit classification for the third consecutive year (reflecting high audit standards), and complied with all regulatory requirements Including timely tax filings. In accordance with cooperative regulations, the Society made all required profit appropriations: for example, 25% of net profit was



transferred to the general reserve, and 1% of net profit was contributed to the NCUI Cooperaåve Education Fund. Additional allocations were made to other reserves (such as bad debt reserves and member welfare ftnds) and a reasonable dividend was provisioned for members, ensuring that surplus eamings strengthen the Society's financial base and support its cooperative development initiatives.

Overall, FY 2024—25 was a year of steady growth and community impact for Prerana Multistate Urban Co-operative Credit Society. The Society's focus on its core mission, financial prudence, technological upgrades, and compliance with cooperative principles has positioned it well to continue serving rural and needy communities in the years ahead.

FAMILY DEVELOPMENT COOPERATIVE THRIFT AND CREDIT SOCIETY LTD., (FAMCO)

1. Introduction:

FAMCO was registered by the Central Registrar of Cooperatives, New Delhi, on the 23rd Day of July, 2009, with the above registration number. FAMCO has been functioning with the following Vision and Mission:

VISIO: To build up an egalitarian society as one family based on the principles of cooperation where the virtues of justice, equality, freedom, fraternity, and peace are the living values of the people at the local, state and national level.

MISSION: FAMCO will work with the poor, the marginalized, the vulnerable, the downtrodden, and the excluded communities and families through their groups/associations and by their participation and sharing. In this process FAMCO will collaborate with Societies, Trusts, Associations, Companies, Cooperatives, and other Organizations which believe in the cooperative/development principles towards the empowerment of the people.

In order to attain the vision FAMCO has been working very hard to achieve the principal object of the Society namely, "to promote the interests of all its members to attain their social and economic betterment through self-help and mutual aid in accordance with the cooperative principles."

2. Membership:

As on 31.03.2025 FAMCO has a total membership of 199 members (72 Individual members and 127 Group Members). The total paid up Share Capital is Rs.19, 36,500/-. The reduction in membership is due to the non-participation of members in the activities of FAMCO for more than three years. It was decided in the 15th AGM held on 12.08.2024 to take away the dormant members of both Individuals and Groups from the list of members. The total number of members as on 31.03.2024 was 460 (117 Individual Members and 343 Group members) and the total paid up Share Capital was Rs.16, 91, 700/-. During the reporting period 14 new Individual Members and 9 new Group Members have joined in FAMCO with a Share Capital of Rs.4,800/- and Rs.1,00,000/-. An additional share capital of Rs. 1, 40, 000/- was mobilized from 10 Group members. Hence the total shares increased during this reporting period is Rs.2, 44, 800/-.

3. Deposits:

The amount of deposits as on 31.03.2025 is Rs. 1, 69, 82, 563.94/-.

4. Loans to SHGs:

The member SHGs are given loan for economic development activities involving micro enterprises and self-employment activities. During the reporting period FAMCO issued a total loan of Rs.1, 25, 00,000/- to 37 SHGs.



5. Inauguration of New Office of FAMCO:

The New Office of FAMCO was set up at No: 81, 1st Floor, Laporte Street, Puducherry-605001. It was inaugurated on 18.-01.2025 at 10.30 am by Prof. Dr. Clement Lourdes, Director, Pondicherry Central University, Chinna Kalapet, Puducherry -605014, in the presence of Rev. Fr. A.S. Antonisamy, Founder and promoter, FAMCO. Rev. Fr. P.A.Aruldoss, Executive Director, PMSSS, Puducherry, blessed the new Office. Prof. Dr. Clement Lourdes, Director, Puducherry Central University delivered the inaugural address. Rev. Fr. P.A.Aruldoss, Executive Director, PMSSS, gave felicitation.

6. Election of FAMCO Board of Directors:

The election to the Board of Directors of FAMCO was conducted by the Returning Officer cum District Magistrate, Puducherry, as per the election order given by the Cooperative Election Authority (CEA), New Delhi. An Assistant Returning Officer was also appointed by the CEA to assist the Returning Officer to conduct the election. Election information letters were sent to all members of FAMCO by the Returning Officer. 13 out of 15 Directors were elected unopposed on 12.08.2024 and approved by the CEA, New Delhi.

7. 71st All India Cooperative Week 2024 celebrated at Chitradurga, Karnataka:

For convenient sake, on 6th December 2024, CHITHRA Don Bosco, Chitradurga, organized a significant meeting and celebration to mark the 71st All India Cooperative Week for members of Self-Help Groups (SHGs) at CHITHRA Don Bosco, Chitradurga.
