## BACKGROUND

The National Cooperative Union of India has constructed the Auditorium at August Kranti Marg, Hauz Khas, New Delhi with multipurpose facilities. The NCUI Auditorium is located at a prime business location and is at a distance of 15 km from the city Airport with modern infrastructure and amenities. The Auditorium is managed by "National Cooperative Union of India which comprises of multiple conference & meeting rooms from 60 to 600 persons seating capacities alongwith lounge and dining area etc.

## **OBJECTIVE**

NCUI has established a state of the art Auditorium in Delhi. The interested party will establish its own team to make maximum booking on behalf of NCUI only for holding the programme of training, meeting/seminars & other HRD related activities/events. No commercial activities will be allowed without taking due permission from the concerned authorities.

#### EOI : DETAILED TERMS AND CONDITIONS FOR ESTABLISHMENT OF OPERATION AND MAINTENANCE OF NCUI AUDITORIUM & ALLIED SERVICES

Interested party will make the booking on behalf of NCUI only for holding the programme of training, meeting/Seminars & other HRD related activities/events. No commercial activities will be allowed without taking due permission from the concerned authorities.

- 1. Interested party will appoint a team for marketing & event management purpose who will exclusively work for NCUI auditorium. Their primary goal will be to maximize revenue through maximum optimization use of NCUI establishment viz. auditorium & meeting halls.
- 2. Interested party will have to repair and maintain all facilities (which shall include furniture & fixtures, fittings, minor civil repair, painting, Air-conditioning, light, sound system etc.) of Auditorium and Conference Rooms to keep the facilities in a good useable condition.
- 3. Interested party has to take all the statutory licenses/NOC from local bodies, health authorities, Police, Delhi Fire Service, electrical department etc.
- 4. Interested party shall make booking on "First Come First Serve Basis, however priority would be given to cooperative organizations.
- 5. Interested party shall be liable and responsible to make payment of all kinds of wages, salaries, remuneration and other benefits etc. to the persons employed by it without claim or reimbursement of any sort from NCUI.

## **GENERAL TERMS IN RESPECT OF EXPRESSION OF INTEREST(EOI)**

- 1. NCUI shall provide permission for booking of Auditorium and Conference Rooms of National Cooperative Union of India (NCUI) 3. Institutional Area, August Kranti Marg, Hauz Khas, New Delhi-110 016, only for the purpose of training, meeting/Seminars & other HRD related activities/events. No commercial activities will be allowed without taking due permission from the concerned authorities.
- 2. The agency would be appointed for a period of 7 years initially which is extendable for further 3 years (maximum 10 years). After the expiry of the period of license or termination of license, the Agency should immediately hand over the vacant possession of the premises to NCUI, failing which Licensee will be treated as a trespasser and will also be able to pay damages Rs.25,000/- per day or @average rate of booking amount prevailing at the time of termination of agreement or expiry of the existing term of the contract whichever is higher.
- 3. The agency shall be in force for the period stipulated in the license and or expiry thereof it shall be deemed to have been terminated (ipso facto) automatically unless otherwise intimated in writing. Further, the agency shall not have a right, either contractual or equitable, to demand any fresh for another term or to continue the same in preference to any other intending agency.

- 4. That the agreement can be terminated by either party by giving 30 days notice in writing. However, no such notice from the licensee would be entertained within three months from allotment of fully operational facilities of NCUI to the agency.
- 5. That the Courts of Delhi at New Delhi shall have jurisdiction to entertain any application in respect of any proceeding under the license or to entertain any suit in connection with the agreement of license and no other court of any other place shall have jurisdiction to entertain any such application or any suit.

Delivery Commitments from NCUI shall be done on mutually agreed terms.
