The National Cooperative Union of India (NCUI) is an apex organization of Cooperative Movement in India. One of the main objectives of the NCUI is imparting education and training to cooperative members, staff and leaders of cooperatives in India as well as from SAARC countries. The National Centre for Cooperative Education (NCCE) under the aegis of NCUI is entrusted with the mandate to organize all educational & training programmes for the benefit of the cooperatives.

We are pleased to announce 30th Diploma in "Cooperative Education and Development" scheduled from 6th October to 19nd December 2025 through online mode. This 12-week programme will be conducted primarily online, with two weeks of in-person classes, examination, viva at NCCE and study visit to various cooperative organisations at New Delhi and outside Delhi. This 12-weeks programme is designed to provide participants with a comprehensive exposure to various aspects of cooperatives and thereby an opportunity to gain a sound understanding on the functioning of cooperative institutions. The course aims to enhance knowledge and managerial skills of the participants about the latest developments in cooperative management and to develop professional knowledge and skills to manage a competitive cooperative business. The programme is particularly intended for the officials working in the cooperative sector, members of cooperative societies and faculty/students from educational institutions.

The in-person classes will be held from 8th December to 19nd December, 2025 which will include study visit, examination and viva. In order to enable the State Cooperative Unions, District Cooperative Unions and other cooperative organizations to take full advantage of the above programme, NCCE provides the following facilities to the participants for attending the programme:

- 1 Lodging at Sai Dham guest house, adjacent to NCUI, New Delhi during in-person sessions i.e. from 07th December to 19nd December 2025.
- 2 Boarding at NCUI, New Delhi during in person sessions.
- 3 To and fro travel cost to NCUI, New Delhi will be borne by the participants/ sponsoring organization
- 4 Training and course materials/presentations.
- 5 Study visits to Cooperatives during the in-person sessions.

The training methodology will include online lectures, discussions, group work, regular assignments, Study visit within Delhi and one outside Delhi. 
You are requested to send nominations of suitable candidates on or before due date enabling us to confirm their admission well in time. Preference will be given to SC/ST/OBC and women candidates.
