

# The Growing Role of **NCEL** in Global Exports



ooperatives are the backbone transformation in India's rural landscape. The rapid expansion and development of the cooperative sector have opened new avenues for holistic rural growth. Under the visionary leadership of Prime Minister Shri

Narendra Modi, the formation of the Ministry of Cooperation marked a new chapter in realizing his vision of "Sahakar Se Samriddhi". The Ministry has undertaken over a hundred significant reforms and initiatives, among which the establishment of National Cooperative Exports Limited (NCEL) as the apex organization to promote cooperative exports is a landmark step.

Under the guidance of Union Home and Cooperation Minister Shri Amit Shah, the Ministry of Cooperation has entrusted NCEL-a multistate cooperative—with the responsibility of accelerating exports across the entire cooperative sector and ensuring that cooperative societies gain access to global markets. Through this institution, Indian farmers and cooperatives are now benefiting from better export opportunities for agricultural, horticultural, dairy, poultry, livestock, and fishery products, as well as sugar, spices, organic goods, fertilizers, handloom and handicraft items, textiles, tea and coffee, minor forest produce, ayurvedic and herbal medicines, processed food, and leather products. This growing participation in global trade is paving the way for the prosperity of millions of farmers and strengthening India's cooperative movement on the world stage.

By August 2025, NCEL had achieved a business turnover of ₹5,403.01 crore through the export of 13.49 lakh tonnes of agricultural commodities, including rice, fresh red onions, sugar, baby food, processed foods, spices, and tea. During this period, 11,034 cooperative societies had become members of NCEL, of which 10,793 are Primary Agricultural Credit Societies (PACS) along with other cooperative organizations.

As a specialized institution, NCEL is working towards maximizing farmers' benefits by addressing key challenges in the export ecosystem such as stiff global competition, market monopolies, corruption, inadequate infrastructure, and lack of standardization. This initiative is ensuring better incomes for farmers associated with cooperatives while expanding the role of the cooperative sector in building a new and developed India.

NCEL's growing contribution is not only strengthening the foundation for a brighter future for Indian farmers but also enhancing the global presence and influence of India's cooperative movement. •••

# Biogas and Potash to be Produced from Cooperative Sugar Mills

India's First Compressed Biogas & Potash Plant Launched in Ahilyanagar

Highlighting the achievements of the cooperative sector, Union Minister for Home and Cooperation Shri Amit Shah inaugurated the country's first cooperative multifeed compressed biogas (CBG) plant in Kopargaon, Ahilyanagar district of Maharashtra. He said that for the first time in the history of India's cooperative sugar industry,

- The first cooperative compressed biogas (CBG) plant will produce 12 tonnes of CBG and 75 tonnes of potash per day
- Cooperative sugar mills are being encouraged to adopt multi-dimensional and multi-feed ethanol production models to ensure year-round operations beyond the crushing season

a compressed biogas plant and potash granule manufacturing unit have been launched at the Maharshi Shankarrao Kolhe Cooperative Sugar Factory. Under this initiative, the Government of India, with the assistance of the National Cooperative Development Corporation (NCDC), will help set up similar plants in 15 selected sugar mills across the country. This landmark step will open a new chapter for cooperative sugar

mills nationwide, paving the way for sustainable, multi-dimensional growth in the cooperative sugar sector.

An investment of about ₹55 crore has been made in India's first cooperative compressed biogas (CBG) plant. The plant will produce 12 tonnes of CBG and 75 tonnes of potash daily from molasses. Shri Amit Shah stated that India imports both these currently products, and this new initiative



marks a significant step toward ending such imports and achieving self-reliance under the vision of Atmanirbhar Bharat. He further said that the Maharshi Shankarrao Kolhe Cooperative Sugar Factory has now become an ideal example of a circular economy.

#### **Emphasis on Making Ethanol Plants** Multidimensional

Emphasizing the need to make ethanol plants multidimensional, Shri Amit Shah said that while the cooperative sugar factories began in Maharashtra, now the state is also leading the way in fully implementing the circular economy model in the sugar industry. He assured that the Government of India will extend full cooperation to the state in this effort. Inspiring others, Shri Shah remarked that the example set by the Maharshi Shankarrao Kolhe Cooperative Sugar Factory should serve as a model for all sugar mills in Maharashtra, helping them achieve greater efficiency and profitability in the coming days. He highlighted that India's first cane-based ethanol plant was also established here. Urging sugar factories to venture into fruit processing, Shri Shah said this will not only promote fruit cultivation but also enhance the profitability of sugar mills, thereby strengthening the cooperative sector's contribution to the rural economy.

#### **Modi Government** Dedicated to the **Welfare of Farmers**

Shri Amit Shah said that the Modi Government is deeply committed to the welfare of India's farmers. Under the leadership of Prime Minister Shri Narendra Modi, the Union Cabinet recently launched the 'Pulses Self-Reliance Mission', with an investment of ₹11,440 crore over the next six years to make India selfsufficient in the production of pulses. Assuring farmers, Shri Shah said that



# A Call to Embrace Swadeshi

Shri Amit Shah said that Prime Minister Shri Narendra Modi has urged all citizens of the country to adopt and promote the use of indigenous (Swadeshi) products. He emphasized that if all 140 crore Indians, including traders and businesses, take a pledge neither to use nor to trade in foreign goods, the purchase of Indian-made products will give unprecedented momentum to the nation's economy.

Shri Shah highlighted that under Prime Minister Modi's leadership, India's economy has risen from the 11th to the 4th largest in the world, and the country now stands on the threshold of becoming the third-largest global economy. He asserted that to achieve the top position in the world, there is no alternative to adopting Swadeshi. Shri Shah appealed to every citizen of the nation to wholeheartedly embrace and promote indigenous products.

the Government of India will procure the entire crop of tur (arhar), urad, and masoor (lentils) from farmers registered with the National Agricultural Cooperative Marketing Federation of India (NAFED) and the National Cooperative Consumers' Federation of India (NCCF) at the Minimum Support Price (MSP). This initiative will benefit farmers not only in Maharashtra but across the entire country.

He stated that the government will purchase pulses from two crore farmers at 100% MSP. Alongside this, 1,000 processing units will be established, and 88

lakh high-quality seed kits will be distributed. Shri Shah further highlighted that in the most recent Cabinet meeting chaired by Prime Minister Modi, the MSP of masoor was increased by ₹300 per quintal, mustard by ₹250, gram (chana) by ₹225, barley by ₹170, and wheat by ₹160 per quintal. He added that over the past 11 years, the Modi Government has raised the MSP of jowar and bajra by two-and-ahalf times and that of tur (arhar), moong, soybean, and cotton by two times—reflecting the government's unwavering commitment farmers' prosperity.

# **Modi Government Empowering Cooperative** Sugar Mills for Farmers' Welfare: Shri Amit Shah

nder leadership of Prime Minister Shri Narendra Modi. India's

cooperative sector is witnessing rapid progress. The number of cooperative sugar mills has increased by 67, sugar production has risen by 1 million tonnes, distilleries have doubled, ethanol production capacity has grown fivefold, and ethanol supply has increased tenfold. Moreover, ethanol blending in petrol has reached 20 %, marking a major milestone in India's renewable energy efforts. These achievements were highlighted by Union Minister for Home and Cooperation Shri Amit Shah during the unveiling of the statues of Padma Shri Dr. Vitthalrao Vikhe Patil and Padma Bhushan Balasaheb Vikhe Patil at Ahilyapur in Maharashtra. Shri Shah said that such progress has been made possible because the people of India and the state have chosen a government that truly cares for farmers. He emphasized that the Modi Government has waived over ₹10,000 crore in taxes for the benefit of farmers—one of the largest relief measures ever taken. Furthermore, cooperative institutions have now been accorded equal status with corporates in tax settlements, ensuring a level playing field.

With this reform, cooperative sugar mills will no longer bear an annual burden of ₹4,400 crore. further strengthen these mills, the National Cooperative Development Corporation (NCDC), under the guidance of the Ministry of Cooperation, has introduced a

dedicated plan to provide financial support to efficient sugar mills, reinforcing the cooperative sector's role in rural prosperity.


Shri Amit Shah urged cooperative sugar mills to transform their ethanol plants into multi-feed ethanol units and continue production even during the non-crushing season. He encouraged them to produce ethanol using vegetable waste, maize, and rice, in addition to sugarcane. For this purpose, the National Cooperative Development Corporation (NCDC) will provide the necessary financial support. Shri Shah further suggested that cooperative sugar mills should diversify into the production of frozen vegetables, fruits, juices, and fruit pulp, thereby expanding their business operations and income sources. He also called upon cooperative sugar mills to collaborate with NAFED and NCCF, urging them to become multidimensional enterprises.

Highlighting the government's commitment to the cooperative sector, Shri Shah said that priority has been given to cooperatives in ethanol procurement and through NCDC's credit schemes, ₹10,000

crore has been sanctioned to support them.

Unveiling the statues of Padma Shri Dr. Vitthalrao Vikhe Patil and Padma Bhushan Balasaheb Vikhe Patil, Shri Amit Shah said that both these eminent personalities made immense contributions to the cooperative movement, rural development, and the welfare of farmers. He said that Padma Shri Dr. Vitthalrao Vikhe Patil dedicated his entire life to the upliftment of farmers. He established the world's first cooperative sugar mill, which not only transformed the lives of farmers in Maharashtra but also benefitted those in Gujarat, Karnataka, Uttar Pradesh, and several other states. Indeed, he was one of the pioneers of India's cooperative movement, ensuring that the profits of sugar mills reached the farmers' bank accounts instead of traders' pockets.

Shri Shah recalled that, on his initiative, the Reserve Bank of India provided a revival package Madhavpura Mercantile Cooperative Bank, which helped save 225 cooperative banks in Gujarat from collapse. ◆◆◆

From primary-level cooperatives to apex-level institutions, those interested in exports are increasingly joining NCEL as members. By establishing strong linkages with international markets, NCEL is empowering cooperative societies, transforming them into vibrant economic entities, and exploring new market opportunities for Indian agricultural products. NCEL plays a pivotal role in linking farmers with export markets, resolving supply chain challenges, obtaining export certifications for agricultural goods, and ensuring smooth logistics and value chain efficiency. This national-level, multi-state

cooperative organization dedicated to agricultural exports stands on the solid foundation of government support and cooperative leadership. NCEL is now poised to become the global face of India's cooperative sector, ushering in a new era of energy, opportunity, and self-reliance in rural India through the cooperative movement.

The NCEL is providing a new direction and strength to India's agricultural and cooperative systems. It marks the beginning of a new era in the growth of the cooperative sector, representing India's cooperatives in global markets. Through NCEL, Indian farmers are now able to export their agricultural produce directly to international and developed markets. The primary goal of NCEL is to channel surplus produce from Indian cooperative societies to global markets based on better demand and fair pricing. 
presence in international trade. Essentially, NCEL has scaled up the cooperative model to the

#### All Cooperative Institutions Should **Export Through NCEL: Shri Shah**

Shri Amit Shah stated that cooperatives are the key to transforming India's rural economy. In agriculture and allied sectors, where there is potential for inclusive growth, cooperatives play a particularly significant role. He said that an ambitious target of ₹2 lakh crore in exports has been set for NCEL. Under this initiative, the Ministry of Cooperation is encouraging cooperatives to "think globally and act locally." This will enable farmers to gain maximum benefits through exports in diverse sectors such as agriculture, horticulture, dairy, poultry, livestock, fisheries, sugar, spices, organic products, fertilizers, handlooms, handicrafts, textiles, tea and coffee, minor forest produce, Ayurvedic and herbal medicines, processed food, and leather.

**NCEL Makes History** in Its First Year

National Cooperative Exports Limited (NCEL) recorded a turnover of ₹4.283 crore and a net profit of ₹122 crore in the financial year 2024-25. Additionally, NCEL expanded exports of Indian cooperative products to 28 countries, taking them to the global stage.

crore and the resultant profits can flow back to the cooperatives. He also suggested setting up NCEL offices in Africa and Myanmar for the import of pulses, and developing a dedicated website to help cooperative members understand global demand and showcase their production capabilities. Emphasizing the need to leverage the strengths of cooperatives, he called for all possible efforts to transform them into successful and vibrant business enterprises.

NCEL Taking Cooperative Produce to Global Markets

NCEL is ensuring that cooperative agricultural products reach targeted customers across the world by addressing major challenges such as intense competition, market monopolies, unfair practices, lack of infrastructure, and standardization issues in the export sector. In just two

years, NCEL has exported millions of tonnes of produce and significantly expanded its membership base, sharing profits with its members.

As India's premier cooperative export organization, NCEL has extended its export operations to 28 countries, covering products such as basmati and non-basmati rice, marine products (especially shrimp), coarse grains, wheat, fruits and vegetables, animal products, spices, and plantation crops. During the financial year 2023-24, NCEL paid a 20% dividend to its member cooperatives, while in 2024-25 it achieved a turnover of ₹4,283 crore and a net profit of ₹122 crore. These achievements reflect NCEL's growing strength and its potential to transform India's cooperative movement into a global economic force.

During this period, NCEL signed strategic Memorandums

of Understanding (MoUs) with 61 importers from Senegal, Indonesia. and Nepal. Delivering impressive results, NCEL had, by August 2025, granted membership to 11,034 cooperative societies, including 10,793 Agricultural Primary Credit Societies (PACS), 216 tehsil and districtcooperatives, multi-state cooperative societies, 10 state-level cooperative societies, and five promoter cooperatives organizations. and Through NCEL, more than 13.49 lakh tonnes of agricultural commodities - including rice, fresh red onions, sugar, baby food, processed food, spices, and tea - have been exported, with a total value exceeding ₹5,403 crore.

During the Budget Session of Parliament this year, the government also clarified that NCEL would export 14,92,800 tonnes of non-basmati white rice to 16 countries, 8,98,804 tonnes of broken rice to five countries,

NCEL was approved by the Central Government and was formally registered on 25 January 2023 under the Multi-State Cooperative Societies Act, 2002. This Act governs cooperative societies that operate across more than one state. It allows members to voluntarily form cooperative societies and ensures that they function democratically. The law promotes self-help, mutual aid, and the economic and social wellbeing of members. It also grants functional autonomy to cooperative societies and addresses related matters to ensure their effective governance and accountability.

# Strategies to Expand NCEL's Reach and Market Presence

To achieve its export targets and strengthen its position in the market, NCEL has adopted multiple strategies to expand its reach and market presence. It has signed Memorandums of Understanding (MoUs) with various state nodal agencies and developed business plans to engage with Primary Agricultural Credit Societies (PACS). To further enhance cooperative-based agricultural exports, NCEL signed an MoU with the Agricultural and Processed Food Products **Export Development Authority** (APEDA) in September 2025. This

partnership focuses on training and capacity building, quality compliance, infrastructure support, and participation in international trade fairs. also emphasizes international branding, market positioning, data-driven market intelligence, and commodity-specific export strategies.

As a significant step in this direction, NCEL launched a commodity seminar series prepare farmers and cooperative societies for exportoriented production, with the first seminar held in Madhya

Pradesh in July 2025. A 'wholeof-government' approach was adopted by collaborating with nodal agencies, offices of the Registrars of Cooperative Societies, and other stakeholders to design commodity-specific strategies. Alongside this, NCEL strengthened its branding and digital outreach through social media, marketing tools, and awareness campaigns. To further expand membership, particularly from PACS, a dedicated Business Process Outsourcing outreach programme was also initiated.

rime Minister Shri Narendra Modi said that the development of Bihar is essential

for the development of the nation. For Bihar to progress, the growth of Purnea and the Seemanchal region is extremely important and today, this region stands at the centre of the development agenda. He expressed these views while laying the foundation stone and inaugurating development projects worth approximately ₹40,000 crore in Purnea district. Referring to these projects related to railways, airports, electricity, and water, the Prime Minister said that they are instrumental in fulfilling the aspirations of the Seemanchal region.

Reaffirming his commitment to

- → With the inauguration of the new airport, Purnea is now on the aviation map of India
- → A state-of-the-art railway network is rapidly taking shape across Bihar

providing pucca houses to every needy family, Shri Modi highlighted that in the last 11 years, his government has built more than four crore pucca houses for the poor, and work is underway to construct an additional three crore houses. Giving priority to the underprivileged and serving the poor, he said, has always been the core objective of his governance.

Remembering Engineers' Day, Prime Minister Modi highlighted the crucial role of engineers in building a Developed India and a Developed Bihar. He noted that the terminal building of the Purnia airport

has been constructed in a record time of less than five months. He formally inaugurated the terminal and flagged off the first commercial flight. With the launch of the new airport, Purnia has now been placed on the country's aviation map.

Speaking about strengthening regional connectivity through an advanced railway network, the Prime Minister flagged off one Vande Bharat train, two Amrit Bharat trains, and one passenger train. He also announced the inauguration of the new Araria-Galgalhia railway line and laid the foundation stone of the Vikramshila-Kataria railway

line. Referring to the recent approval of the Mokama-Munger section of the Buxar-Bhagalpur High-Speed Corridor, he stated that it will greatly benefit industrial hubs such as Gayer, Jamalpur, and Bhagalpur. The government has also approved the doubling of the Bhagalpur-Dumka-Rampurhat railway line, further boosting regional development and connectivity.

Recalling Engineers' Day, Prime Minister Modi highlighted the crucial role of engineers in building a Viksit Bharat and a Viksit Bihar. He noted with pride that the terminal building of the Purnea Airport was constructed in a record time of less than five months. He then inaugurated the new terminal and flagged off the first commercial flight. With the launch of this airport, Purnea has now been placed on the aviation map of India. Speaking about strengthening connectivity across the region, the Prime Minister flagged off one Vande Bharat, two Amrit Bharat and one passenger train. He also announced the inauguration of the new Araria-Galgalia rail line and laid the foundation stone for the Vikramshila-Kataria rail line. Referring to the recent approval of the Mokama-Munger section of the Buxar-Bhagalpur High-Speed Corridor, he said this will greatly benefit industrial hubs like Geher, Jamalpur and Bhagalpur. The government has also approved the doubling of the Bhagalpur-Dumka-Rampurhat railway line.

Highlighting efforts to make Bihar self-reliant in the power sector, the Prime Minister informed that the foundation stone has been laid for a 2,400 MW thermal power project at Pirpainti in Bhagalpur. He affirmed that both the Central and State governments are committed to increasing the income of farmers and livestock-rearers. Shri Modi also announced the launch of the first



phase of the Kosi-Mechi Intra-State River Link Project.

Calling makhana cultivation a major source of income for Bihar's farmers, the Prime Minister said he had promised the people of the state the creation of a National Makhana Board. The notification establishing the Board has now been issued. The Board will continuously work to ensure better prices for farmers and promote the use of technology in the sector. The government has approved a development plan of approximately ₹475 crore for the makhana sector. Referring to the ongoing development projects worth thousands of crores across Bihar, Shri Modi described the hosting of the Hockey Asia Cup in Raigir, the historic construction of the Aunta-Simaria bridge, and the export of Bihar-made locomotives to Africa as major achievements of the state.

Referring to the announcement of the Demographic Mission to address the demographic crisis emerging in Seemanchal and Eastern India due to illegal infiltrators, the Prime Minister said that it is the government's responsibility to stop infiltration. He affirmed that strict action will be taken against infiltrators and the country will soon witness positive outcomes.

Highlighting the rise of women as "Lakhpati Didis" and "Drone Didis", he said these women, through

Self-Help Groups, are leading transformational revolution. Informing that nearly ₹500 crore has been released as a Community Investment Fund for women, the Prime Minister said that this amount will reach cluster-level federations, which will further empower SHGs in villages. This initiative will create new opportunities for women to enhance their skills and economic strength.

Announcing a major relief for the poor and middle class, the Prime Minister stated that with the reduction in GST rates, the prices of most daily-use items in the country will fall. Household kitchen expenses will come down significantly. The cost of stationery used for children's education will also decrease, making it easier for families to buy new clothes and shoes for their children.

Recalling the role of Purnia's brave sons during the freedom struggle in showcasing India's strength to the British, the Prime Minister said that the Nation has once again demonstrated the same strength to its adversaries through Operation Sindoor. Highlighting the significant contribution of a brave son of Purnia in the strategic execution of this operation, he asserted that whether it is national security or national development, Bihar plays a vital role in advancing the country's progress. •••

in connecting emerging startups with investors and accelerating the journey toward a developed and self-reliant India. He noted that since Prime Minister Shri Modi

launched Startup India in 2016, India has become the world's thirdlargest startup ecosystem within just eight years. Today, India is the fastest-growing country in building a world-class startup environment. Startups in India are no longer just profit-generating units; they have become a powerful medium for empowering youth, fostering self-reliance, and turning their aspirations into reality.

Shri Shah added that under Prime Minister Modi's leadership, India has also emerged as the world's thirdlargest digital ecosystem over the past decade, enabling young minds to present their ideas, innovation, and courage swiftly to the nation and the world. As a result, India has risen from the 91st rank in the Global Innovation Index in 2015 to the 38th position today. Shri Shah expressed confidence that within the next three years, India will rank among the top ten countries in the Global Innovation Index and will soon be a leader in driving global innovation.

He emphasized that the Modi government has, from the beginning, created a supportive environment for startups, offering financial, policyrelated, infrastructural, banking, and industrial support. Major initiatives include the establishment of a ₹10,000-crore Fund of Funds, the launch of the Startup India Seed Fund with a corpus of ₹945 crore, an increase in the maximum loan limit from ₹10 crore to ₹20 crore, provision of up to ₹20 lakh for Proof of Concept, and funding of up to ₹50 lakh for prototype development. Shri Shah also highlighted reforms undertaken by the governmentsuch as the launch of Make in India, the introduction of PLI schemes in 14 sectors, the removal of over 40,000 compliances, and decriminalization of more than 3,400 legal provisions.

#### 1.92 Lakh Startups and Over 120 Unicorns in 11 Years

Shri Amit Shah said that in the 11 years of the Modi government, India has witnessed numerous



transformations, with significant positive developments across all sectors to expand the startup ecosystem. While there were only 500 startups in 2014, today India has 1.92 lakh startups—an increase of 380 times. Similarly, the number of unicorns has grown from 4 to more than 120, valued collectively at over 350 billion dollars.

Shri Shah urged industry leaders to partner with startups and expand in every sector to further increase the number of unicorns. He emphasized that India today has 21,000 startups in the IT sector, 17,000 in healthcare, and 11,000 each in agriculture and education. Startups have now spread across 770 districts, demonstrating the strength and reach of India's startup ecosystem. Currently, 52 percent of startups operate in Tier-2 and Tier-3 cities.

Shri Shah highlighted that 48 percent of startups in India are founded by women, including 900 women-led startups in the Northeast. He added that the startup ecosystem has generated 17,90,000 permanent jobs so far. He further stated that Gujarat has consistently ranked first in the country for four consecutive years in the startup sector. With 16,000 startups, Gujarat is among the top five states, while Ahmedabad, with 6,650 startups, ranks among the top four cities. Shri Shah noted that the startup sector is

the leading emerging sector in the country, and Prime Minister Modi envisioned increasing its speed, size, scope, and scale — a vision that is now becoming a reality on the ground.

#### Release of the Compilation on the Indian **Knowledge System**

On this occasion, Shri Amit Shah released a compilation on the Indian Knowledge System and said that it encompasses the finest knowledge in the world across fields such as Ayurveda, classical arts, architecture, mathematics, philosophy, science, space, and the environment. He noted that under the New Education Policy, the government has created a dedicated vertical for research and study on the Indian Knowledge System, thereby opening this vast treasure to the youth of India. Drawing from this repository, India's young researchers can produce world-class innovations and scholarship.

Referring to GST reforms, Shri Shah said that the Modi government has undertaken a major simplification and transformative reform of the GST system. The country has witnessed, for the first time since Independence, such a massive reduction in taxes. He added that these GST reforms have helped build a bridge of trust between the taxpayers and the government. •••


motorcycles and cars. Several leading national and international companies are setting up factories in Gujarat. Vadodara has now begun the manufacturing of transport aircraft.

Expressing regret over previous government's lack of development, Shri Shah said that during the past 26 years of Delhi's rule, the people of Delhi had been deprived of progress. The previous government had promised to clean the Yamuna River and take a dip in it, but they had forgotten their promise. He noted that during the previous government's rule, garbage

Shri Shah stated that Shri Modi has recently completed 24 years of continuous service as Chief Minister and Prime Minister. mountains in Delhi had grown to 65-meter high. Shri Shah stated with full conviction that on January 1, 2028, Delhiites would no longer see mountains of garbage; instead, beautiful gardens would begin to be built in those places. He lamented that in the past 11 years, the previous Delhi government had blocked all the schemes that Prime Minister Shri Modi had intended to provide to the people of Delhi. Shri Shah said that the previous government had prevented the implementation of the Government of India's Ayushman Bharat scheme, which provided free treatment up to ₹5 lakh to Delhi residents, depriving them of its benefits. Shri Shah pointed out that the 57 Mohalla Clinics opened by the previous government were severely under-equipped: lacked X-ray machines, 21 lacked pulse oximeters and 38 did not even have thermometers. He stated that under such conditions, no patient could receive proper treatment in these clinics.

Expressing his concern, Shri Shah said that the previous government had been involved in numerous scams over its 11-year tenure, including in areas such as Mohalla Clinics, CNG, liquor, advertising, medicines, classrooms, the Delhi Jal Board, Sheesh Mahal, CCTVs, and panic buttons. He also noted that before Shri Modi's tenure. the central government had been implicated in scams worth ₹12 lakh crore. In contrast, during Prime Minister Shri Modi's 11 years in office, not a single allegation of corruption has been reported, reflecting that our governments are truly dedicated to the welfare of the people.

Shri Shah highlighted that on the first day of Navratri, Prime Minister Shri Modi reduced GST rates on more than 395 items. bringing them down to either zero or five percent. Additionally, in the 2025-26 budget, the government exempted income up to ₹12 lakh from income tax. the inauguration of the building and hostel for students of Shri Parasmal Bohra Netraheen Mahavidyalaya in Jodhpur, Rajasthan. He stated that Prime Minister Shri Modi first began using the term "Divyang" for specially-abled people in 2015, and this decision has changed the way the Government of India,

all state governments, and the citizens of the country perceive persons with disabilities. Under Shri Modi's leadership, the government has increased the budget of the Department of Empowerment of Persons with Disabilities from ₹338 crore in 2014 to ₹1,313 crore. Until 2014, the Indian government



had provided prosthetic limbs and devices to only 7 lakh people. However, in recent years, the Modi government has organized 18,000 camps to provide prosthetic limbs to 31 lakh people.

The government has provided extensive facilities for people with disabilities. Under the Accessible India Campaign, 1,314 Government of India buildings have been made accessible at a cost of ₹563 crore. # **GST Reforms Fulfilling Citizens' Dreams**

he steadily advancing toward the vision of a Self-Reliant India.

The upcoming phase of Goods and Services Tax (GST) reforms is expected to accelerate India's growth trajectory, simplify business operations, and attract investments, ensuring that every state becomes an equal partner in the nation's development journey. In his address to the nation, Prime Minister Shri Narendra Modi highlighted that these tax reforms have been designed to address the concerns of all sections of society.

Reflecting on the first major step in tax reforms in 2017, Shri Modi emphasized that the government prioritized GST in the interest of both the citizens and the nation. Every concern was carefully considered through extensive consultations with stakeholders, resulting in a system that unified multiple taxes across the country. This marked the realization of the long-standing dream of "One Nation, One Tax."

Describing reforms as an ongoing process, the Prime Minister noted that as circumstances change and national priorities evolve, nextgeneration reforms are essential. The new GST framework has been designed with both the present needs and future aspirations of the country in mind. Under this revised structure, only two tax slabs -- 5% and 18% -- will remain, making most everyday essentials more affordable. Items like food, medicines, soap, toothbrushes, toothpaste, health and life insurance will either

be exempt from GST or taxed at the lower 5% rate.

Referring to the neo-middle class, which has lifted 25 crore Indians out of poverty over the past 11 years and significantly contributed to India's growth, the Prime Minister acknowledged their aspirations dreams. The government has already provided income tax relief by exempting income up to ₹12 lakh. Now, the focus is on the underprivileged and neo-middle class, who will benefit from reduced GST rates, making it easier for them to achieve their goals. Purchases such as homes, TVs, refrigerators, scooters, bikes and cars will now be more affordable and travel costs will also decrease with the reduction in GST on most hotel rooms.

Highlighting the principle of "Nagrik Devo Bhava", Shri Modi stated that the combined effect of income tax relief and GST reductions will save Indian citizens over ₹2.5 lakh crore. This initiative has therefore been termed a "Savings Festival," reflecting the government's focus on easing financial burdens and enhancing the quality of life for all.

Underlining the need for firm commitment to the path of selfreliance to achieve the goal of a developed India, Shri Modi said that a major responsibility for making India self-reliant rests with MSMEs - India's micro, small, and cottage industries. # **Cooperative Movement Strengthens the Vision of 'Sahkar se Samriddhi'**

Modi's vision of "Sahkar se Samriddhi", the Ministry of Cooperation is charting a new course for the country's cooperative movement. Under the leadership of Union Home Minister and Minister of Cooperation, Shri Amit Shah, the cooperative sector has expanded from its traditional focus on agriculture and credit to emerging areas such as healthcare, services, and valuechain development. To make cooperatives more people-centric and future-ready, the Ministry is prioritizing the integration of modern technology with strong institutional and human capacity building. These insights were shared by Dr. Ashish Kumar Bhutani, Secretary, Ministry of Cooperation, at a two-day national workshop and review meeting held in Tirupati, Andhra Pradesh. The event emphasized speeding up the digital transformation of the cooperative ecosystem, ensuring complete digitization of PACS, enhancing the digital skills of PACS employees and members, and enabling PACS to evolve into onestop centers offering a wide range of services—including agricultural inputs, credit, procurement, and storage.

During the workshop, detailed updates were provided on the

ongoing computerization PACS, ARDBs, and the offices of the Registrar of Cooperative Societies. The Central Registrar of Cooperative Societies (CRCS) also briefed states on the issues and challenges faced by multistate cooperative societies and urged them to strengthen coordination for smoother functioning. The progress of the National Cooperative Database

(NCD) was reviewed, highlighting that it now includes more than 8.4 lakh cooperative societies and 32 crore members across 30 regions. Underscoring the crucial role of PACS and multi-state cooperatives as drivers of rural development, self-reliance, and digital advancement, the Secretary called for deeper collaboration between central and state agencies. He emphasized the need



to leverage digital tools and datadriven insights for more effective governance of cooperatives. States were encouraged to act on the agenda of "Reform, Performance, Transformation, and Information" to strengthen the cooperative sector. The discussions also covered the contribution of cooperatives in the insurance sector, with representatives from IFFCO-Tokio sharing their perspectives.

#### **Emphasis on Completion** of Cooperative Projects

The event highlighted importance of ensuring the timely execution of cooperative schemes, promoting transparency in financial operations, and maintaining sustainable management of cooperative resources. underscored that all states and union territories should contribute their data to the National Cooperative Database (NCD) to facilitate balanced development across the country. Under the leadership of Shri Amit Shah, the Ministry of Cooperation is actively addressing challenges related to banking. Efforts are also being made to diversify cooperative businesses to enhance income opportunities for cooperative banks strengthen and local

entrepreneurship. In the presence of representatives from state and union territory governments, secretaries, Registrars of Cooperative Societies (RCS), and other key stakeholders, the workshop reviewed the progress of three national-level multi-state cooperative societies under the Self-Reliance Campaign—namely, National Cooperative **Exports** Limited (NCEL), National Cooperative Organic Limited (NCOL), and Indian Seed Cooperative Societies Limited (BBSSL).

#### Accelerating the Implementation of the **Grain Storage Scheme**

The Ministry of Cooperation is actively working to fast-track the implementation of the world's largest grain storage scheme within the cooperative sector. Initially launched as a pilot with 500 PACS, the scheme has now been expanded to 29,000 PACS across the country. During the workshop, discussions focused on ensuring the sustainability economic of warehouses through PACS business diversification, mapping PACS based on land availability, cooperative strength, and existing infrastructure, and providing technical and managerial support for long-term viability. The review also covered the formation and strengthening of two lakh multipurpose PACS, dairy, and fisheries cooperatives across all panchayats and villages. Special emphasis was placed on identifying potential districts and blocks for cooperatives, revitalizing existing societies through business activation and diversification, and ensuring last-mile connectivity to enhance rural livelihoods.

Top cooperative leaders from across India highlighted significance of the International Year of Cooperatives 2025 (IYC-2025) and urged states and union territories to actively organize its flagship events. Additionally, states were encouraged to take the lead in major initiatives like the national tree plantation "Ek Ped Maa campaign, Naam," and to institute awards recognizing cooperative societies for their progress in these areas. The workshop also underscored the importance of strategic public relations in giving new direction to cooperatives, encouraging the extensive use of social media to showcase innovative practices and exemplary cooperative models. \*\*\*

This inspiring revitalization of rural communities is being led by the Durgachaumuhani Farmers Organization Producer (FPO) in Kamalpur, Dhalai district of Tripura in northeastern India. The FPO is bringing about notable transformation while expanding market access for farmers. become a model for farmers both within the state and across the

Established around three years ago, the FPO now has roughly 800 members, with women accounting for nearly one-fourth of the total. The participation of Scheduled Castes and Scheduled Tribes is also significant. The organization encourages members to boost food production by providing essential inputs such as seeds, pesticides, fertilizers, agricultural tools, and other forms of support. It also assists farmers in marketing their

produce, ensuring they receive fair and competitive prices. In doing so, the FPO is strengthening rural livelihoods and supporting the overall development of the local economy.

To further improve market access, the organization has signed agreements with several major cooperative institutions. Notably, it has partnered with IFFCO for fertilizers and related supplies, and with Wellnext Seeds for high-quality seed varieties. These collaborations have minimized the influence of middlemen and

helped ensure fair compensation for farmers.

To benefit its members even more, the Durgachaumuhani FPO is embracing modern technology. It has registered with the Open Network for Digital Commerce (ONDC), enabling farmers' produce to reach consumers across the country and even globally through digital marketplaces. Additionally, the FPO is promoting environmental protection high-quality production bγ adopting sustainable agricultural practices.

#### **Significant Achievements** of Durgachaumuhani FPO

The Durgachaumuhani FPO has accomplished several major milestones to date. It has established a small bank of agricultural equipment that includes three power tillers, two power weeders, ten spare parts, and two water pumps. This machinery is benefiting farmers by enhancing crop productivity and boosting their incomes. The organization has achieved a turnover of ₹7.4 million. Through support from the Agriculture Department, it has also distributed free agricultural inputs—such as seeds fertilizers—to its members, helping reduce their production costs. Looking ahead, the FPO plans to adopt drone and sensor-based farming technologies. To enhance the value of farmers' produce, it is preparing to set up processing units, along with packaging and branding facilities. Efforts are also underway to market the produce at both national and international levels.

#### **Focus on Training Programs** for Skill Development

The Producer Farmer Organization conducts training programs to build the skills of its members and officials. These





programs familiarize them with modern technologies and provide knowledge on innovative and advanced farming practices. In addition, training is offered in computer use, accounting, and legal matters. The FPO also emphasizes collective business strategies through cluster-based activities. It plans to facilitate access to loans and grants for its members by collaborating with government

schemes and financial institutions. In the future, the organization aims to ensure greater prosperity for farmers by adopting modern technologies such as drone- and sensor-based farming, expanding membership, establishing processing units, adding value through packaging and branding, and marketing their products national and international markets. \*\*\*

amendments related to Panchayati have ensured reservation for women in local bodies and municipalities. Furthermore, the Multi-State Cooperative Societies (MSCS) Act of 2023 mandates the inclusion of two women members on the boards of cooperative societies. Women have particularly excelled in the dairy cooperative sector. The National Cooperative Union of India (NCUI) also runs educational and field project programs for women promote their participation and empowerment through cooperatives.

The NCUI is dedicated to women through empowering training programs that help them achieve self-reliance. Several development skill initiatives are being organized in Bhopal, Shimoga, and Imphal to promote women's empowerment. Since the establishment of India's first Ministry of Cooperation on July 6, 2021, special emphasis has been placed on supporting women. In line with this, a budget allocation of ₹3 lakh crore was approved in the Budget to enhance the lives of women.

Women's collective participation in development is being strengthened through self-help groups. Mudra loan limit for small, micro, and medium enterprises (MSMEs) has been raised to ₹20 lakh. In this context, the cooperative sector is playing an active role in implementing initiatives. Cooperatives established specifically for women's development-- such as the Women's Welfare Cooperative Societies, which number 25,092 according to the National Cooperative Database-can utilize these funds for growth

and empowerment. These resources can be directed toward organizing more skill development programs for women and enhancing market access for women-led self-help group enterprises. Cooperatives also hold potential for shaping a brighter future for India's youth. With every third urban resident being young, India is on track to become the world's youngest nation, with 64% of its population in the working-age group. At present, a large portion of India's youth receive education through cooperative institutions, including universities and senior secondary schools.

Youth can establish product cooperatives, service-based allowing them to apply their education more effectively within the cooperative framework. So far, youth involvement in cooperatives has largely been limited to campuslevel activities. However, students in colleges and training institutes are now participating in supply chains for small but essential items such as notebooks, books, pens, and pencils, which are sold through small youth cooperatives on campus. These cooperatives also provide services like ticket booking, travel insurance, computer training, and more. Youth cooperatives are engaged in smallscale savings and loan activities. It is expected that the upcoming policy--focused cooperative cooperative education and training, along with the establishment of a National Cooperative University-- will further encourage the participation of both women and youth in the cooperative movement. •••
