**For continuing of the Membership of NCUI, according to the bye-laws no. 9 of N.C.U.I the schedule- I of membership rates accordingly**

- (i) each member society shall pay annual subscription to the Union at the rates as may be decided by the Governing Council from time to time.
- (ii) annual subscription from members shall fall due at the commencement of each cooperative year, i.e. on the 1st day of April every year and shall be payable by 1st July of the year.
- (iii) In case of default in payment of membership subscription, the member society shall be liable to pay penal interest at the rate as may be decided by the Governing Council from time to time.
